## Notes

### Conditions

Under the Wireless Telegraphy Act 1949 a licence issued by the Secretary of State is required before any person may establish or use any station for wireless telegraphy or install or use any apparatus for wireless telegraphy in the UK and UK territorial waters.

To be eligible for a Class B Amateur Radio (Novice) Licence you must:

- have attended the Novice Licence training course  
have obtained a course completion slip  
and
- have passed the Novice Radio Amateurs' Examination (NRAE)
- The date of completion of the training course must precede that of the pass for the examination.

For a Class A Amateur (Novice) Licence you must

- have passed the Novice Morse Test  
and have either:
- complied with Class B (Novice) requirements  
or
- have been a full Class B licensee for at least a year

### Publication of name and mailing address

The Radiocommunications Agency permits publication of your name and mailing address in a call book, if you have consented by ticking the appropriate box.

If you have not consented, only your callsign will be published. If this call book is compiled, stored and published by a third party, either in written form or by "read only" computer disks, it will be made clear to the third party that the information will be disclosed to it for the publication of a call book and for no other purpose.

### Renewal payments

Please note that Licences are free to the under 21's and from 1 April 2001 to those aged 75 years or older. If you are under 21 or 75 and over at the time of renewal, you only need to sign and return the Remittance Advice Note to indicate that you wish to continue.

### Requesting a callsign

If you would like to request a particular callsign in the current series of callsigns, you may do so at the callsign section overleaf. Before filling this in, you should telephone RLC to check that the callsign is available. The callsign will only be issued to you once your full application is received by them and callsigns are issued on a "first come first served" basis. Please note that if you previously held a callsign, this will be re-issued to you and you will not be able to request another callsign.

Please enclose a cheque or Postal Order for the fee valid at the time of application made payable to Radio Licensing Centre and crossed "A/C Payee". Please print your name and customer reference number on the reverse of your cheque or postal order. Do not send cash. If you wish to pay by credit/debit card please provide the following details:
