The Future of Digital Terrestrial Television

I have attached this as required by the Ofcom web site contact procedures in order that I can include Computeractive and The Gadget Show in the debate.

Your consultation requests responses regarding the future of digital television in this country and I have replied before via the online form but on further reflection feel that in the light of HDTV Freeview in the offing that the current digital switch over must be *stopped* now.

Ofcom should ensure that the roll out of HDTV Freeview is accelerated nationally at the earliest opportunity. So that the whole country can have HDTV Freeview for the Olympics in 2012 or earlier. As currently people are restricted to paying for Sky's inflated services unless they live in a cabled area.

This would prevent people having to buy another Freeview box in a couple of years time. I have four Freeview set top boxes and will have to buy another four when HDTV Freeview becomes available.
