**Freedom of Information: Right to know request**

Thank you for your request for information where you asked about Amateur Radio Licence Statistics.

This was received by Ofcom on 6 August and it has been considered under the Freedom of Information Act 2000 (FOIA).

You asked:

*Dear Office of Communications,*

*From data held on Amateur Radio Licenses, please furnish the following information :-*

*The total number of individuals holding one or more current UK Amateur Radio Licenses as of 1/8/2018.*

*N.B. For the avoidance of doubt this total should NOT include keepers of Club/ Repeater licenses, NOV's, or SCC's etc.*

As of 1 August 2018 I can confirm that the total number of individuals holding one or more current UK Amateur Radio Licences is 75,660.

**Correction to previous FOIA request in response letter dated 17 April 2018**

It has come to our attention that the figure in our letter to you dated 17 April 2018 concerning Amateur Radio Licence statistics as of 1 April 2018 is incorrect. As at that date, the correct figure for the total number of individuals holding one or more current UK Amateur Radio Licences is 74,646.

However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review.
