**Question 1: Do you agree that copy management would broaden the range of HD content available on DTT and help secure its long term viability as a platform? :**

I am not in favour of any action which allows content to be restricted and thus not available for reasonable and fair use.

It is my belief that any mechanism of this nature will not affect the dissemination of content by those prepared to work around it, but it will affect those that simply wish to watch on a different device or at a different time of their own choosing.

No, my view is that I do not wish to see any changes to what is permitted in this regard. On air formats should be free, documented and open in all respects.

No, I believe that any changes made will add cost, and more importantly incompatibility, into HD DTT receivers. I am totally against such an approach.

**Question 7: Do stakeholders agree that the BBC's proposed Huffman Code licensing arrangements would have a negligible effect on the market for HD DTT receivers? :**

No, it is my opinion that this approach will lead to crippled and incompatible implementations of receivers. The market should not have these restrictions applied to it.

**Question 8: Do the BBC's proposed content management states and their permitted use for different categories of HD content meet the requirements of other HD broadcasters on DTT? . :**

I am entirely uninterested in the requirements of other HD DTT broadcasters, I am interested in not permitting the BBC to make changes that disadvantage licence payers in what they may do with programmes received on HD DTT receivers.
