Question 1: which services are most likely to drive take up of DTT consumer reception equipment using new technologies? In particular, are HD services the most likely to do so?:

reasonably priced HD receiving equipment (HD Freeview boxes) or an exchange scheme if standard boxes have been brought in a pre determined period before HD is launched. Interactive services and compatibility with computer interfaces

Question 2: do you agree with Ofcom's assessment that it would be beneficial for the DTT platform to begin to upgrade to new technologies? DVB-T2 and MPEG-4 - to make more efficient use of spectrum and to allow for the introduction of new services?:

Yes, I agree. But first Ofcom must secure a common agreement for the standard of the format used across the european zone. This will improve competitiveness in the same way the PAL system has done for video and will stop the format being hijacked by large corporations with vested interests.

Question 3: Ofcom is particularly interested in hearing from multiplex operators and programme providers as to whether they are interested in using DVB-T2 and / or MPEG-4, and whether Ofcom should consider permitting their use on DTT?:

without support from the content providers HD provision will fail miserably - there is only 1 opportunity to get it right for the people of the UK and europe - this opportunity, Ofcom needs to make thoroughly considered decisions for the long term benefit of provider, operators and programme providers.

Question 4: do you agree that the earliest possible availability and adoption of the technologies is in the interests of consumers and citizens?:

yes, but only if the standard format DVB-T2 and or MPEG-4 (I would prefer MPEF-4 for long term compatibility) is agreed across the european area. Of commust also consider the need to provide compatibility when new technologies will replace either of the above formats (as they inevitably will). Only if this is agreed should availability and adoption be made at an early time.

Question 5: do you agree with Ofcom's view that DVB-T2 MPEG-4 reception equipment could be commercially available in time for DSO in Granada region in late 2009?:

yes, I agree about the reception format equipment, but it should be funded by Ofcom for a fixed period of evaluation with an option for the Granada region people who take up the option for HD to buy the equipment at a reduced price as an incentive.
