I cannot see how what the BBC is wishing to do, could in any way be made to safeguard our existing rights of fair use and our ability to use open source (and hence cheaper) solutions. As an academic this would have a grave impact on what I could use in my teaching and would give a technical impediment to what I could otherwise legally do with the material.
