## Summary

- Wolverhampton DAB Ltd founded by Wolverhampton's first and longest-running Ofcom-licensed community radio station WCR
- WCR is the largest participant with a 32% shareholding and is a corporate director.
- Ambur Community Radio is a 5% shareholder and corporate director.
- WCR and Ambur are two of 6 radio services that will operate C-DSP licensed services on the multiplex
- Excellent coverage from a single low-cost transmission site
- Experienced technical team that has successfully implemented and launched small-scale DAB multiplexes across the UK
- 28 signed heads of terms from committed service providers plus 4 expressions of interest.
- Extensive engagement with more than 30 service providers

## 2. Extent of proposed coverage area

Wolverhampton DAB's technical plan uses a single-site to cover the main populated areas of Wolverhampton. We have included a coverage prediction to illustrate our proposals. The extent of our proposed coverage reaches 85.5% of the Ofcom licence area polygon population with a further 23% (88,368) reaching neighbouring towns and villages for whom Wolverhampton is their main destination for work, leisure, study and shopping.

Our aim is to deliver good quality indoor and outdoor coverage across the polygon in a way that maximises coverage yet stays within the parameters laid down by Ofcom in terms of overspill, overlap and the protection of other named polygons. We can achieve this through the use of the following transmission site:

1. Mander Centre - a major shopping centre in Wolverhampton City Centre which opened in 1968.

### Coverage

Wolverhampton is situated northwest of its larger neighbour Birmingham, and it is a second largest part of the West Midlands conurbation. To the north and west lies the Staffordshire and Shropshire countryside.

Wolverhampton refers to itself as 'The City of the Black Country' and the local authority area also encompasses the traditional towns of Bilston and Wednesfield. It has also recently become the first location outside of London to house a major ministerial department in the form of the Department for Levelling Up, Housing and Communities. It is part of the West Midlands Combined Authority area and works increasingly closely with the other cities of the region (Birmingham and Coventry)

Wolverhampton DAB' coverage area spans from Featherstone in the north, to Tipton in the south; and from Perton in the west to Shoreheath and Darlaston in the east. Our plan covers the densely populated conurbations Codsall, Essington, Newbridge, Willenhall, Bilston, Wednesfield.

Wolverhampton city centre is just outside of the area which is known under the name the Black Country. Today people tend to use the term West Midlands to refer to the western part with an exclusion of Birmingham, Solihull, and Coventry.

The city lies at 163m or 535 ft above the sea level upon the Midlands Plateau.

Wolverhampton has no major rivers in the city, but there are tributaries of River Trent – the River Penk and River Tame which rise in the city, as well as Smestow Brook, which is a tributary of the River Stour.

- the number of people falling outside the Wolverhampton polygon does not exceed 30% of the total population within the advertised licence area; and
- the proposed coverage does not overlap more than 40% of the population within the relevant local radio multiplex service’s licensed area.

The transmitter network has been designed to minimise any significant interference above 38 dBµV/m to other proposed small-scale DAB licence areas.

## Financial and business plan

A detailed financial forecast that sets out establishment costs, annual income & outgoings with 36-month cash flow and profit & loss forecasts is included in Appendix A. This has a contingency for inflation reaching 15% built in to the figures.

### **Capital Investment – £24,000**

The main capital investment is the multiplexing & transmission system. In selecting Viamux to provide the small-scale DAB solution as well as professional services (project management, site surveys, network design and build, software configuration, installation, training and ongoing support) Wolverhampton DAB was mindful of their wealth of experience implementing DAB systems, the competitive pricing of their solution and the many customer references they have in the UK.

### **Operating Costs – £20,000 (per annum)**

#### Transmission

The ongoing costs associated with transmission (site rental, electrical power consumption, internet provision) are the single most important recurring operating expenditure for a multiplex company. Our choice of transmission sites is a cost-effective choice that balances delivering the largest audience whilst ensuring carriage fees remain attractive to service providers.

#### Technical Support & Maintenance

Ongoing technical support for maintaining the multiplex and transmission equipment will be provided by Viamux (by way of an annual support & maintenance contract).

#### Small-Scale DAB Management Software

Wolverhampton DAB will subscribe to Optimux - the low-cost cloud-based control panel that simplifies management and monitoring of a small-scale DAB network. For a low-cost monthly fee, Optimux allows us to implement cloud encoding - making it quick, easy and cheap to add new services to a multiplex. It also provides us with full invoicing and direct debit collection to streamline the payment of carriage fees. Optimux also monitors the multiplex and will alert us to any issues and notify service providers regarding their audio.

#### Administration

The usual administration costs associated with operating a business of this size are included (insurance, legal and accountancy services) as is the annual Ofcom licence fee.

#### Funding

The project is funded through a combination of equity and a shareholder working capital loan. The multiplex operation will be established and sustained by providing existing community and commercial broadcasters, as well as new entrants, with a reliable digital broadcast platform on both affordable and flexible terms.

Post award, we will take responsibility for the day-to-day general management of the multiplex operation - managing commercial, financial and operational matters. This is simplified through the use of Optimux and with the ongoing support of Viamux..

Tasks include, but are not limited to;

- Recruiting new services;
- Issuing carriage agreements;
- Invoice management;
- Payment collection; and
- Working with programme services to ensure DSPS and regulatory licence compliance.
- Monitoring and Ofcom reporting

### Team

The participants share a track record of successfully establishing and operating broadcasting operations including small-scale DAB multiplexes.

### Key Personnel

#### David Duffy

David's involvement in radio dates back to 1981 (Essex Radio). He was launch director of Wire FM, the commercial radio station in Warrington. In 2004 he founded Cheshire FM and served as its first Chief Executive. In 2008 he led a group in the acquisition of Southport commercial radio station Dune FM and subsequently Preston's Central Radio.

In 2013 David established Niocom Associates to provide professional consultancy services to the broadcast sector. In 2015 Niocom was awarded one of the ten trial small-scale DAB trial licences (Manchester) which has been running successfully for over seven years. In 2017 David co-founded [Viamux](#) to deliver low-cost DAB solutions for small-scale DAB operators. Viamux's first customer was the Irish State Broadcaster, RTÉ. Viamux went on to work with ComReg, Ireland's communications regulator, to operate a DAB multiplex in Cork - the first independent small-scale DAB multiplex trial in Ireland. Viamux is working with small-scale DAB licensees across the UK (see 3.22). In 2020 David co-founded Optimux Digital – developer of the [Optimux dashboard](#) for managing small-scale DAB.

### **Chris Hurst**

Chris Hurst has worked in commercial radio for over 30 years. He's been a director and Ofcom licence holder for over 23 years. Chris was the Local Radio Managing Director of the LSE quoted Wireless Group PLC with responsibility for 10 local stations and 3 local multiplexes until it was acquired in 2002 by LSE quoted UTV Media PLC he continued in the position until 2009 at which point he had responsibility for 17 analogue radio stations, 7 digital stations and 4 local multiplexes. In 2009 he took a shareholding in Dee 106.3 Ltd and became its CEO a position he continues to hold. The Dee Radio Group went on to acquire Silk FM Ltd.

Chris is a strong believer and supporter of DAB, and the Dee Radio Group has launched digital services Dee on DAB, Love 80s Liverpool and Love 80s Manchester. Love 80s Manchester broadcasts on the small-scale trial multiplex in Manchester and is the only small-scale service in the UK that publishes RAJAR. The Dee Radio Group co owns the local multiplex for NE Wales and West Cheshire and Chris is a director of the holding company Muxco NE Wales and West Cheshire Ltd.

Chris was a consultant general manager of community station Pure 107.9 between 2009 and 2017 during which time Pure successfully applied for a grant to establish the Great Manchester Community Radio Alliance which ran for a number of years.

Chris is actively engaged in the radio industry as a whole and sits on the RadioCentre Advisory Group.

Chris attended Harvard Business School in 2005.

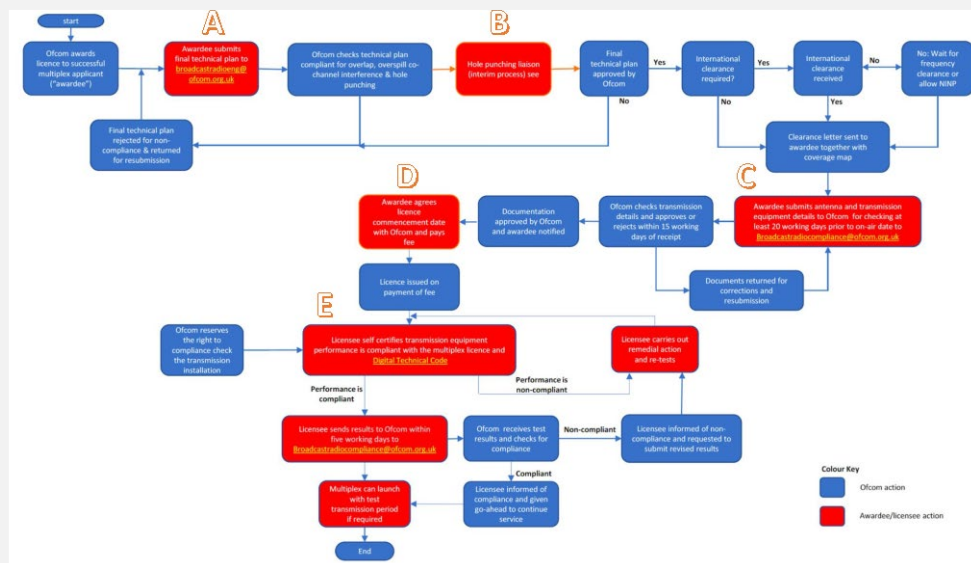
## Timetable for coverage roll-out

Wolverhampton DAB’s aim is to launch the multiplex within 5 months of the licence award subject to Ofcom approval of our final technical plan.

Funding is already in place and Heads-of-Terms are sufficient to exceed the operating costs of the multiplex. We are continuing to actively pursue all expressions of interest and are confident to launch with a strong line-up of services.

Following the ‘Guide to Launching’ flowchart and the procedures set out in Ofcom’s Technical Policy Guidance we aim to accelerate the implementation timetable by focusing on stages A to E.



Stages:

- A. In response to any technical mitigations in the award letter, we aim to finalise our site agreements and technical plan and submit to Ofcom within 4 weeks.
- B. On receipt of the hole punching document we will liaise with the national & local multiplex operators immediately. Responses received will be sent to Ofcom.
- C. Once the technical plan is signed off by Ofcom the equipment will be ordered and specifications shared with Ofcom. Installation date is scheduled and Ofcom is notified with twenty days’ notice.
- D. Equipment is installed and commissioned.

As a leading small-scale DAB provider, Viamux will manage the implementation of the project. Availability of all equipment, software and professional services to meet our timescales are already confirmed.

We will be responsible for finalising site agreements and arranging broadband connectivity. A project GANTT chart (Appendix E) details the tasks, activities and timescales under which the implementation will be governed to achieve our target launch date.

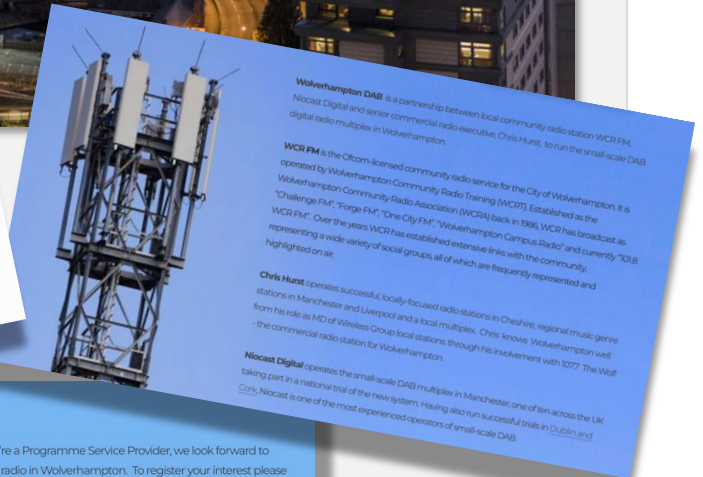
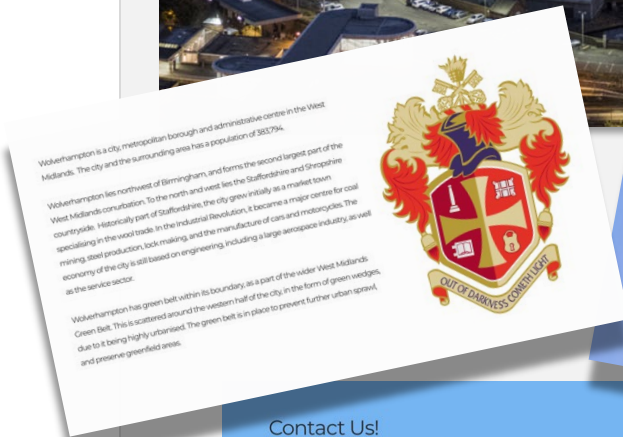

## Wolverhampton's WCR FM to apply for small-scale DAB licence

SMALL SCALE DAB WCR FM



Community station WCR FM is to apply for the new small-scale DAB multiplex for the city of Wolverhampton.

Wolverhampton DAB Ltd has been established by WCR FM station director Chris Allen with the help of Niocast Digital, Credible Media and radio executive Chris Hurst.

"WCR FM has been around since 1986 in one form or another," says Chris Allen. "And we've been planning the move to DAB for some time now. We're looking forward to the quality that DAB will deliver and being able to reach lots more listeners.

"We want to hear from stations interested in having their radio service carried on the multiplex to make contact via the form on our website at

[WolverhamptonDAB.co.uk](http://WolverhamptonDAB.co.uk)".

- Outreach - Wolverhampton DAB has also conducted research to identify active community and internet radio services. We made direct contact via email or phone to ensure that radio operators were aware of the opportunity and if they were interested in participating in the project at this time. We contacted the universities and the local college to make them aware of the opportunity that the service could offer their student radio stations. We also contacted the local hospital radio service with the same offer.
- Consultation - Following the receipt of expressions of interest Wolverhampton DAB engaged in early conversations with potential C- DSP and DSP providers, to give them an indication of pricing and capacity. From the consultation we were able to identify those that would enter into heads of terms and those that were keen but were only able to commit to an expression of interest at this stage.

**Following the award of licence**, Wolverhampton DAB will take steps to secure carriage agreements with those services that have signed heads of terms and engage openly with those services providers who completed expressions of interest:

Allocation or reservation of capacity is subject to the Service Provider either holding a DSP or CDSP Licence or being able to demonstrate that they have submitted their application to Ofcom for a DSP or CDSP Licence, respectively.

- If all the reserved capacity spaces on the multiplex have been allocated, additional service providers with CDSP's can be offered an unreserved space
- If the capacity on the multiplex is reached, a waiting list will be created with service providers kept up to date on any future availability.

Throughout this process, Wolverhampton DAB has openly discussed our transmission plans, carriage terms and indicative fees. We have engaged with potential service providers in an open, non-exclusive manner and will continue to do so throughout the duration of this licence. As stated above, each service provider will enter into a carriage agreement - the key terms of which are identical for all service providers. All fees charged will be pro-rata to capacity contracted by each service provider. In contracting or offering to contract with programme services providers, we will continue to act in a manner that ensures fair and effective competition.

**Following the launch of the multiplex**, Wolverhampton DAB will continue to operate a transparent rate card policy, published on our website. The structure of our rate-card will reflect our core aim of supporting and encouraging community broadcasting by C-DSP licensed services with pricing to help them establish a long-lasting partnership with us for mutual sustainability.
