## Providing new application payment contact details - OfW586b

### Guidance for completing this form

#### Who should use this form?

You may use this form to provide payment contact details and optionally to set up a Direct Debit mandate with Ofcom, when you apply to establish an Aeronautical Radio Ground Station in the United Kingdom, Isle of Man, Jersey, Guernsey or on a platform in the UK Continental Shelf. For a new application this form must be accompanied by one of the following completed application forms:

- Aeronautical ground station radio licence application form – [OfW586a](#);
- Aeronautical radar ground station licence application form – [OfW593](#); or
- Aeronautical navigational aid radio ground station licence application form – [OfW594](#).

Additionally, OfW586b can be used for changing the payment contact details.

#### Communication preference

Where possible, we send correspondence to licensees electronically. By applying on-line and providing your email address, we assume that you wish to receive correspondence and notifications relating to Wireless Telegraphy Act licences electronically and not on paper.

If you do not wish to receive documents electronically, you must opt out by ticking the box against the contact in question A.1.
