

# Satellite (earth station network) radio licence application form: non-geostationary – OfW602

## **Guidance for completing this form**

#### Who should use this form?

You may use this form to apply for, amend or surrender a non-geostationary satellite (earth station network) licence in the United Kingdom. For geostationary satellite networks, please use application form OfW103.

#### **Conditions**

Under the Wireless Telegraphy Act 2006, you must have a licence issued by Ofcom before you establish or use any earth station radio equipment unless it is authorised by a specific exemption.

#### **Communication preference**

Where possible, all correspondence will be sent to licensees electronically.

If you do not wish to receive documents electronically, you must opt out by ticking the box against each contact to receive correspondence by post.

#### Completing this form

Before completing this application form, you are advised to read the <u>additional guidance</u>. Ofcom intends to publish applications for this licence to allow other parties to provide information regarding interference or the competitive impact. Before publishing, Ofcom will redact the personal information contained in this form. You also have the option to provide confidential information in answer to the questions in Section D.

When completing this application please refer to the notes and complete in dark ink in BLOCK CAPITALS.

All fields are mandatory unless stated otherwise.

#### **Payment**

Payments should not be included with this application. Ofcom will invoice later. Payments must include all bank charges. If Ofcom does not receive full payment, it will return any partial payments received.

#### Radio licence fees

The licence fee should only be paid to Ofcom after you have been invoiced. The licensee must pay the relevant fee as provided for by section 12 of the WT Act and the Regulations that have been made under that section. If you fail to pay the licence fee, Ofcom may revoke the licence.

**SECTION A – Application purpose** For a new satellite (earth station network) licence

#### Radio interference

Since the operation of a new system may cause interference to existing users, your supplier may consider it necessary to carry out compatibility tests before you apply for your licence. Once installed and operating, your system must not cause undue interference to any other wireless telegraphy equipment. If it does, you may need to stop operating until the cause of the interference has been rectified. Ofcom cannot offer any protection against interference radiated by other authorised services, or by industrial, scientific and medical equipment; however, if you do experience interference, please contact us.

If you need to make a change to an existing licence, then enter your licence number for question A.2.

If you no longer need your Satellite (earth station network) licence, then you can simply surrender it by providing your licence number and date of surrender in question A.3.

# SECTION B – Customer details Question B.1a – Existing customers

If you already hold an Ofcom radio licence, you should write your customer reference number in the box provided. Your customer reference number will be quoted in licence documentation or correspondence that we have previously sent to you.

#### Question B.1b - Harmonising a licence

Ofcom can align invoices for similar licence products to one consolidated date. This makes invoicing and payments easier to manage.

The conditions for harmonising a licence are:

- The licence must be under an existing customer reference number;
- Must be the same licence product;
- Must have identical payment terms (e.g. every 5 years);
- Must have an identical payment contact; and •
   Must be no outstanding invoice against the licence.

#### Question B.1.c - Short-term duration

This question need only be answered if the required duration of the licence is for a period of less than 12 months. You should enter the start and end dates in the format DD-MM-YYYY.

legal personality. This can be an individual or a business or other body with its own legal personality. You should complete the appropriate option provided. For a business partnership, limited partnership, trust, syndicate, club, or society without any separate personality, an individual will need to be nominated as the licensee – they will hold the licence as a nominated trustee on behalf of the body and be legally responsible for compliance of all terms of the licence.

#### Question B.3 - Licensee address

If you are applying on behalf of a Limited Company, a Public Limited Company or a Registered Charity, the registered address of the organisation must be used. The licensee will receive all licensing documentation and correspondence.

#### **Question B.4 – Licence contact name and address**

If the licensee is a business or other body with its own legal personality, you must provide the contact details for an individual that will be responsible for the licence in this section. You can also complete this section where the main point of contact that should receive licensing documentation and correspondence will be different to the licensee.

This individual will receive licensing documentation that does not relate to billing, invoicing, and account queries.

**Note**: Ofcom may notify licensees of proposals to vary or revoke licences by publishing a general notice on its website and may not individually contact licensees to inform them of our proposal. 
