

## **Notification under Section 107(6) of the Communications Act 2003**

### **Proposal to give a direction applying the Electronic Communications Code to Wight Cable 2005 Ltd**

1. The Office of Communications (“Ofcom”) propose to give a direction under section 106(3) of the Communications Act 2003 (the “Act”) applying the electronic communications code (the “Code”) to Wight Cable 2005 Ltd (registered company number 5470659).

**[Draft] Direction under Section 106(3) of the Communications Act 2003  
applying the electronic communications code in the case of Wight Cable 2005  
Ltd**

**[A Notification of this proposal was published on 9 February 2006]**

Whereas:

- (A) On 24 January 2006, Wight Cable 2005 Ltd (registered company number 5470659) made an application for the electronic communications code (the "Code") for the purposes of the provision of an electronic communications network in the United Kingdom in accordance with section 107(1) of the Communications Act 2003 (the "Act") and the notification published by the Director General of Telecommunications under section 107(2) of the Act on 10 October 2003 setting out the requirements with respect to the content of an application for the electronic communications code and the manner in which such an application should be made;
- (B) On 9 February 2006, Ofcom published a notification of their proposal to give a direction applying the Code to Wight Cable 2005 Ltd in accordance with section 107 of the Act;
- (C) Ofcom have considered every representation made to them about the proposed Direction;
- (D) For the reasons set out in the explanatory statement accompanying this Direction, Ofcom are satisfied that they have acted in accordance with their relevant duties set out in sections 3, 4 and 107(4) of the Act

**NOW, therefore, pursuant to section 106(3) of the Act, Ofcom make the following Direction-**

1. The electronic communications code shall apply to Wight Cable 2005 Ltd for the purposes of the provision by Wight Cable 2005 Ltd of an electronic communications network to have effect in the United Kingdom.

Definitions and Interpretation

2. In this Direction, except in so far as the context otherwise requires, words and phrases shall have the same meaning as in the Act, headings and titles shall be disregarded and expressions cognate with those referred to in this Direction shall be construed accordingly.
3. The Interpretation Act 1978 shall apply as if this Direction were an Act of Parliament.
4. This Direction shall take effect on the day it is published.

# Explanatory Statement

1.1 On 24 January 2006, Wight Cable 2005 Ltd (“Wight Cable 2005”) applied to Ofcom for a direction applying the electronic communications code (the “Code”). This application was made in accordance with section 107(1) of the Communications Act 2003 (the “Act”) and meets the requirements for any such application for a Direction applying the Code, and the manner in which such an application has to be made, as set out in the Notification published by the Director General of Telecommunications on 10 October 2003 under section 107(2) of the Act.

1.2 In considering Wight Cable 2005’s application, Ofcom has acted in accordance with its relevant duties set out in sections 3 and 4 of the Act. In particular, Ofcom has considered its duty in section 3(1)(b) “to further the interests of consumers in relevant markets, where appropriate by promoting competition” and the first Community requirement set out in section 4(3)(a) to promote competition “in relation to the provision of electronic communications networks and services”. In this case, Wight Cable 2005 intends to install an electronic communications network which will deliver basic telephony, data, television and radio services.

1.3 The assets that were owned by Wight Cable Ltd were transferred to Wight Cable 2005 on 16 December 2005. Wight Cable 2005 intends to develop and expand upon this existing asset base and potentially provide electronic communications services to customers beyond the reach of its present network. The intended infrastructure build will significantly increase the size of its network and to manage this efficiently Wight Cable 2005 considers that Code powers would be of benefit to it in deploying additional infrastructure and maintaining its current infrastructure.

1.4 Ofcom has considered the application with regard to its duties set out in section 107(4) of the Act. Its views on the matters set out therein in relation to Wight Cable 2005’s application are set out below.

## **The benefit to the public of the electronic communications network by reference to which the Code is to be applied to the applicant**

1.5 Wight Cable 2005 offers various electronic communications services including basic telephony, data based services and television. The present network passes approximately 13,000 homes and the planned additional infrastructure build will more than double the network’s reach in terms of the homes that it will pass. The expansion of its network will increase competition in the provision of a range of electronic communications services spanning a number of markets and, therefore, consumers’ choice.

## **The practicability of the provision of the network without the Code**

1.6 Wight Cable 2005’s plans include extensive network build the majority of which will be provided via a broadband radio solution. Other elements will require the installation of additional ducting. In both cases, however, Wight Cable 2005 stated that its ability to deploy the infrastructure would be hampered by planning restrictions that would otherwise apply under the New Road and Street Works Act 1991 and Town and Country planning legislation<sup>1</sup>.

1.7 Ofcom considers that Wight Cable 2005 would be able to deploy additional infrastructure and maintain it thereafter more simply and quickly if it benefited from Code powers. Moreover, it would be placed at a competitive disadvantage if it did not benefit from such powers. Ofcom considers, therefore, that Wight Cable 2005 should be granted such powers.

### **The need to encourage the sharing of the use of electronic communications apparatus**

1.8 Wight Cable 2005 explained that wherever possible it would be willing to share ducting to minimise disruption to public highways and this practice would be a continuation of practices already in place. The company also explained that it has – pre-the asset transfer – and will continue to have regard to other undertakers' rights – that is, those benefiting from the ability to install or maintain infrastructure – in relation to network build and/or maintenance in planning further build and will try to coordinate such works wherever possible.

### **Whether the Applicant will be able to meet liabilities as a consequence of:**

**(i) the application of the Code; and**

**(ii) any conduct in relation to the application of the Code**

1.9 Wight Cable 2005 has confirmed that it would put cover in place to safeguard appropriate authorities should a relevant event occur.

### **How to respond**

1.10 Ofcom invites written views and comments on the issues raised in this document, to be made by 5pm on **13 March 2006**.

## **Confidentiality**

1.14 Ofcom considers that it is important for everyone interested in an issue to see the views expressed by consultation respondents. ## **Next steps**

1.18 Subject to respondents' views, Ofcom proposes to grant Code powers to Wight Cable 2005 and would intend to do so shortly after closure of the consultation period.

## **Ofcom's consultation processes**

1.19 Ofcom is keen to make responding to consultations easy, and has published some consultation principles (see Annex 1) which it seeks to follow, including on the length of consultations.

1.20 This consultation is shorter than Ofcom's standard 10 week period because Ofcom considers that it the best interests of citizen consumers would be served by allowing Wight Cable 2005 to deploy its network quickly and Code powers would assist with the deployment of it.

## Annex 1

# Ofcom's consultation principles

Ofcom has published the following seven principles that it will follow for each public written consultation:

### Before the consultation

1 Where possible, we will hold informal talks with people and organisations before announcing a big consultation to find out whether we are thinking in the right direction. If we do not have enough time to do this, we will hold an open meeting to explain our proposals shortly after announcing the consultation.

### During the consultation

2 We will be clear about who we are consulting, why, on what questions and for how long.

3 We will make the consultation document as short and simple as possible with a summary of no more than two pages. We will try to make it as easy as possible to give us a written response. If the consultation is complicated, we may provide a shortened version for smaller organisations or individuals who would otherwise not be able to spare the time to share their views.

4 We will normally allow ten weeks for responses to consultations on issues of general interest.

5 There will be a person within Ofcom who will be in charge of making sure we follow our own guidelines and reach out to the largest number of people and organisations interested in the outcome of our decisions. This individual (who we call the consultation champion) will also be the main person to contact with views on the way we run our consultations.

6 If we are not able to follow one of these principles, we will explain why. This may be because a particular issue is urgent. If we need to reduce the amount of time we have set aside for a consultation, we will let those concerned know beforehand that this is a 'red flag consultation' which needs their urgent attention.

### After the consultation

7 We will look at each response carefully and with an open mind. We will give reasons for our decisions and will give an account of how the views of those concerned helped shape those decisions.

## Annex 2

# Consultation response cover sheet

2.1 In the interests of transparency, we will publish all consultation responses in full on our website, [www.ofcom.org.uk](http://www.ofcom.org.uk), unless a respondent specifies that all or part of their response is confidential. We will also refer to the contents of a response when explaining our decision, unless we are asked not to.

2.2 We have produced a cover sheet for responses (see below) and would be very grateful if you could send one with your response. This can include information such as your personal background and experience. If you want your name, contact details, or job title to remain confidential, please provide them in your cover sheet only so that we don't have to edit your response.
