Question 1: Do you agree that copy management would broaden the range of HD content available on DTT and help secure its long term viability as a platform?:

No. It will be an inhibitor and is counter to the intent of Freeview.

Who is to say how Freeview is delivered? It may be to an integrated TV with Freeview receiveer or a set top box or indeed a software implementation on a PC running only the most basic of RF and decoding in silicon. Therefore to meet the concept of "Freeview" the algorithms need to be public and therefore easily circumventable.

Also there is HD kit already on the market. This would cause interoperability issues and once again show a complete lack of joined up thinking re broadcast in the UK.
