## **Additional comments:**

Question 1: Do you agree that copy management would broaden the range of HD content available on DTT and help secure its long term viability as a platform?:

No I do not agree. It has been shown time and time again that this form of digital rights management does not stop the criminal, it only stops legitimate users from easily accessing services. As a licence-payer, I would like the ability to save recorded content onto various consumer devices, many of which do not support drm.

Many of those who share copyrighted tv programmes will continue to do so by working around this content management system. As they will do this, the only people who are left encumbered are those who watch legitimately, and would like to view the HD content using open source software, and devices that do not have a licence for the content management systems. A similar example is DRM in video games, hackers find a way around them, and they do not work - only legitimate users are penalised for paying for their content.
