Freedom of Information: Right to know request

Thank you for your request for information in relation to unlicensed radio stations in London between January 2015 and January 2022. We received this request on 27 January 2022 and have considered it under the Freedom of Information Act 2000 ("FOI Act").

Your request

You asked for the following information:

- 1. Number of raids carried out on suspected unlicensed radio stations in London each year, between January 2015 and January 2022, broken down by year and London borough.
- 2. Number of raids on unlicensed radio stations in London which resulted in seizure of equipment between January 2015 and January 2022, broken down by year and London borough.
- 3. Number of prosecutions against individuals related to unlicensed radio stations, in London, between January 2015 and January 2022, broken down by year and London borough.
- 4. Number of transmitters taken down in London related to unlicensed radio stations between January 2015 and January 2022, broken down by year and London borough.
- 5. Number of complaints or allegations made by the public, or by license paying broadcasters, regarding possible unlicensed radio stations in London, between January 2015 and January 2022, broken down by year and London borough.
- 6. Cost of enforcement action regarding unlicensed radio stations in London, between January 2015 and January 2022, broken down by year and, if possible, by London borough.

Our response

We have responded to each of your questions in turn below. Due to Ofcom's data retention policy, we no longer hold the requested from 2015. We are therefore only able to provide information from August 2016 onwards, unless otherwise stated. We also note that with the exception of question 3, Ofcom does not record the requested data broken down by London boroughs.

- 1. Number of raids carried out on suspected unlicensed radio stations in London each year, between January 2015 and January 2022, broken down by year and London borough.
- 2. Number of raids on unlicensed radio stations in London which resulted in seizure of equipment between January 2015 and January 2022, broken down by year and London borough.

We have interpreted your reference to "raids carried out" as a reference to where a search warrant is executed at a property containing part or all of an illegal broadcast station. The relevant numbers by calendar year are as follows:

¹Please note that we only hold information within the scope of this question from May 2016 onwards, due to a change in our internal complaints management system.

If you ask us for an internal review of our decision, it will be subject to an independent review within Ofcom.

The following outcomes are possible:

- the original decision is upheld; or
- the original decision is reversed or modified.

Timing

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter**. There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review. If you wish to request an internal review, you should contact <u>information.requests@ofcom.org.uk</u>.

If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision.
