By providing greater flexibility to our commitment to original output, Future Radio will be able to resource more work within the community, and greater training opportunities to new & existing volunteers, and to others beyond Future Radio. Our ethos is to support better futures for those in our community, this change would allow us to spend more time on delivering that ethos.

As stated, our training programmes and other projects within our community would not change. Our focus on providing a voice for people who would not otherwise be heard would also not change. Our speech output will continue to focus on delivering important information to our listeners and facilitating discussion on issues affecting our community and will be unaffected by these changes.

Future Radio last reviewed its key commitments in 2016 and much has changed since then. A move to new premises following the station's landlord entering liquidation, the subsequent effect that had on our volunteer base and the resulting financial challenges it produced has led to the new station management reviewing Future Radio's Key Commitments now.

The changing broadcast landscape within our city, since our Key Commitments were last reviewed, including recent changes to local commercial radio and BBC local radio's output, provides us with an opportunity to provide a more diverse range of music and speech content. The proposed changes to our Key Commitments will enable us to provide an alternative to the pop focussed output of the national stations.

In addition, the cost of living crisis continues to challenge the availability and commitment of volunteers and the proposed changes to our Key Commitments will provide us with the flexibility to ensure that we continue to provide original and local content across the week, rather than having to focus on filling gaps when volunteers become unavailable.

Ofcom Notes on the Request

The request was AGREED, because Ofcom was satisfied in relation to Section 106(1A)(a) of the Broadcasting Act 1990 (as modified by the Community Radio Order 2004, and further modified by the Community Radio (Amendment) Orders 2010 and 2015) i.e. that the change would not substantially alter the character of the service, and for the policy reasons given below.

The Licensee has asked to convert its original output requirement from daily to weekly, alongside a reduction from 84 hours a week to 63 hours a week total. This represents a 25% reduction in their original output requirement. The Licensee has explained that changing circumstances have reduced the availability of volunteers.

We are satisfied that a move from a daily to a weekly target will allow the licensee greater flexibility in managing its resources, and that the relatively modest reduction in weekly hours is unlikely to compromise how the service is received by listeners over the course of the week.

The licensee has also requested to modify their existing Key Commitment for their music output from including soul and dance as genres to instead including alternative as a genre and a 'range of specialist music genres and local music'. The licensee has stated that their volunteer steering group is supportive of the proposed changes. They have also argued the change will allow them to focus on promoting the local music scene and delivering programming to underserved communities, as well as providing representation on air.

Future Radio's core purpose as set out in its Key Commitments is to 'act as a voice for the local community', deliver 'inclusive programming' including to 'underserved groups' and facilitate participation of these groups. As such, we do not consider that a change to the types of music the station must play is likely to have an impact on its ability to continue delivering on its core purpose. Indeed, it could be argued that the change to include local music might help facilitate the service to act as a voice for the local community. Taken with the fact that the volunteer steering committee has not expressed opposition to this move, Ofcom has taken the view that the changes to the Key Commitment for their musical output would not affect the service's ability to appropriately serve its target community.

In terms of our policy criteria, we do not consider these changes are in conflict with the community radio 'characteristics of service' as set out in the legislation, and for the reasons set out above we consider the extent of the impact of the change on the character of the service to be low. We are therefore approving this request under section 106(1A)(a) of the Broadcasting Act 1990, and for these policy reasons.
