

Additional comments:

Question 1: Do you agree with the consumer harm identified from Communications Providers? ability to raise prices in fixed term contracts without the automatic right to terminate without penalty on the part of consumers?:

Yes

Question 2: Should consumers share the risk of Communications Providers? costs increasing or should Communications Providers bear that risk because they are better placed to assess the risks and take steps to mitigate them?:

If the nature of an agreement is to set payments for the term of the arrangement, and the Providers still insist it is not an arrangement subject to the Consumer Credit Act, then they must cover the risk themselves for the duration of the original term.

Question 3: Do you agree with the consumer harm identified from Communications Providers? inconsistent application of the ?material detriment? test in GC9.6 and the uncertainties associated with the UTCCRs?:

OfCom need to provide INDEPENDENT assessment and guidance

Not if the Providers continue to tie consumers into contracts longer than 12 months

No, not so long as they insist on providing contracts longer than 12 months

They are best placed, but they need to conform to Plain English guidelines in making such communications

They should apply to existing contracts too, else consumers that have entered into contracts before the requirements come into force could be extremely adversely affected, inasmuch as the Providers could increase the costs of their newly entered contract to cover any perceived or real losses the Provider may suffer by following the new regulations. Additionally, in the lead time to the introduction of the regulations, an unscrupulous provider could be tempted to create many loss-leading, cheap-at-first, lengthy contracts that they can then vary the costs of without sanction during the term.
