It adds security to the system which is (for the most part) not available. However whether it is active is as yet unproven. Other much more complex and potential secure DRM systems, such as Blu-ray, have failed in the past. History shows that most DRM systems are subverted within days of release, so it seems there will be little 'benefit' for some considerable annoyance to legitmate users.

No. As stated for Question 2 the system will not provide any extra security for content producers and would serve to hinder consumers of HD content. Restrictions would include the ability to move the content to alternative playback devices following recording on a PVR, the use of 'niche' PVRs for example Windows Media Centre and MythTv. Both of which are currently HD Freeview ready but with this new level of protection will be unable to receive HD content without significant (and not guaranteed) updates. Many consumers have purchased expensive systems based on the ability to receive Freeview HD with them.

Question 6: Do you agree that the BBC?s proposed choice of content management technologies will have only a negligible impact on the cost of HD DTT receivers and their interoperability with other HD consumer equipment? .:

No. Interoperability with other HD equipment will doubtless be affected as much of this equipment already exists and is unlikely to be updated with new security systems. HD DTT receivers used in computers will require new software which will not be available for sometime, if at all.

Yes. HD DTT receivers will be created to work with the new system, however other devices sold on an international market may not be able to work with a UK specific system
