Additional comments:

Question 1: Do you agree that copy management would broaden the range of HD content available on DTT and help secure its long term viability as a platform?:

No. It has been proved that free open source techniques provides a larger working base of people able to produce content, as they do not have to pay-in to closed restrictive managed systems.

Question 2: Do you agree that the BBC?s proposed multiplex licence amendment represents the most appropriate means for securing an effective content management system on HD DTT?:

No. The entire proposal to lock or retrict access to BBC produced materials is morally wrong. I have paid my license fee and believe that the content produced with it should be open. I would rather go without third party media (non-BBC produced content) than submit to restrictive practices.

Question 3: Do you agree with the proposed change to Condition 6 in the Multiplex B Licence?:

No. I strongly disagree with any restrictive content management system.

I believe that the impact would be negative. the Open Source providers would find that they have to include restricting non open segments in their hardware which would plainly not be possible. This proposal would therefore have a negative impact on the Open source community of manufacturers and the people who wish to use their equipment.
