**Freedom of Information: Right to know request**

Thank you for your request for information where you asked about correspondence between Ofcom and TalkTalk about Telecom2 Ltd.

This was received by Ofcom on 15 August and it has been considered under the Freedom of Information Act 2000.

*We have been informed by TalkTalk Ltd that a letter/email was sent by Phil Jones of Ofcom concerning numbers hosted by Telecom2 Ltd.*

*TalkTalk stated to Telcom2 the following: The issue was raised with OFCOM and PSA. OFCOM requested via email that an AIT retention was raised on the basis of misuse. Email sent by Phil Jones of Ofcom on 22nd June 2018 @09:44.*
