**Question 1:What are your views on the strategic principles that Ofcom proposes to apply to its numbering policy decisions? :**

Too expansionist and appearing to offer more choice to companies so that they can bamboozle the consumer into paying more for their services.

**Question 2:What do you think are consumers? key current views on numbering, how do you think those views will change, and how should Ofcom?s current decisions take those changes into account? :**

Don't let companies force consumers to pay extra for calling them because the company chooses to use a non-geographical code (ie 0845). As these non-geographical codes are not often included in calling packages consumers cannot save money on them. We don't expect freephone, just fairphone.

Other numbers should only be allowed if there is no financial penalty to the consumer from calling it (ie same charges as geographical 01 & 02 numbers).

Ban adult content from being supplied by overseas providers at huge expense whilst hidden by the veneer of a 09 number - or better still, ban the content entirely.

**Question 12:Should any specific PRS service categories be identified or segregated in order that parents can block access by their children (e.g.,sexually explicit content, gambling)? Is there merit in having a general ?adults only? classification, including a range of services to which access might be restricted on the grounds of content, or might consumers wish to apply different rules for different types of content?:**

Yes. Allow consumers to block access to PRS services and any that are not in the 01/02/08/08 or emergency services range. Porn lines and gambling sites should be subject to the same controls as the high street ie over 18s only.

Announce the per minute call charge when connecting the call (like some calling cards do).
