1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). The application form is divided into two parts Part A (which we will publish on our website) and Part B (which will be kept confidential). This document constitutes Part A; Part B of the application form is available here.
- Small-scale radio multiplex licences are awarded by Ofcom in a competitive process. Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.

How to complete the form

- 1.3 There are detailed instructions on how to complete this form, and information on the next steps in the application process, in our <u>guidance notes</u> for licence applicants and licensees. Please read this guidance and the frequently asked questions carefully before completing this form.
- 1.4 If you still have a query having read the guidance and FAQ, you can contact Ofcom's Broadcast Licensing team by email (<u>broadcast.licensing@ofcom.org.uk</u>). The team cannot provide advice or pre-approve applications, but can answer general questions.
- 1.5 Please download this form and fill it in on a computer. If completing by hand, please use block capitals and black ink.
- 1.6 Please answer all the questions as fully as possible, use extra sheets if required and provide the supporting documentation listed at Section 7 of Part B of the application form. Sufficient information must be supplied about the applicant and the proposed service to enable Ofcom to consider the application in accordance with the statutory criteria for the granting of small-scale radio multiplex licences. Ofcom may need to request further details from you before a licence can be granted.
- **1.7** Of com reserves the right to reject applications made using an old version of the form.
- 1.8 Of com will accept handwritten application forms but they must be filled in using block capitals and black ink.
- **1.9** Of com reserves the right to reject application forms that are illegible.

The target area to be served constitutes an area 15 miles north to south, 15 miles east to west. The coast stretches from the port of Fleetwood in the north, down to the three distinct areas of Blackpool's seafront; north, central and south, and down to the Fylde towns of St Annes and Lytham. The bottom edge of the transmission area heads out to the city of Preston through rural villages, while the M55 motorway cuts through the centre of the area and the top edge borders with Lancaster.

The area is a mix of vibrant towns with Blackpool – which attracts 15 million tourists a year – as its focal point. Upmarket boutique towns like Lytham and Poulton contrast with more sedate towns like Cleveleys and Kirkham.

The Fylde Coast is far more than just a tourist destination. The highest number of jobs (22,000) are in health and social care while the visitor economy employs 19,000 people, manufacturing (19,000), there are 18,000 professional/financial jobs and 18,000 people work in retail. (Lancashire Enterprise Partnership data for the transmission area)

Blackpool is a unitary authority, while Wyre Borough to its north and Fylde Borough to the south fall in Lancashire County Council. See annex document with additional local information.

It is relatively flat terrain and will be covered from one site, Blackpool Tower at 158 metres in height, using a directional antenna. Blackpool's iconic tower is ideally situated on the seafront, central to the broadcast area.

We expect very good coverage across the proposed area. By operating from a single site, that reduces costs and therefore makes DAB radio far more accessible to smaller community organisations.

The coverage prediction document in the annex details the percentage of the population served within the polygon and the estimated overlap with the Lancashire DAB multiplex, which we have kept to a minimum.



Our mission is to provide a multiplex service that can accommodate as many locallygenerated radio services to serve the different groups and interests in the local community on the Fylde Coast. To achieve this, our aim is to make the cost of broadcasting on the multiplex as affordable as possible.

We have sourced a quote for the installation and fit out of the necessary technical equipment from Viamux and the costs associated with operating it. All the annual costs of operating the business are being kept at a minimum.

Letters from the directors are included in Part B to the effect that they will loan the social enterprise the necessary monies to fund the start-up of the multiplex and that they have sufficient resources for this from their private finances. The attached three-year cashflow forecast details how, and over what time period, that loan will be repaid to the directors.

We have been purposefully cautious in forecasting revenue generated in the cashflow document and the number of stations we expect on air. Given the generosity of the owners of the transmission site, which they were happy to offer as we are a not-for-profit company, it is incumbent on us to pass on that saving on to community groups wishing to broadcast on the multiplex. See letter from the owners of the transmission site in Part B.

We also want to ensure that the community groups have the best possible chance of achieving sustainability for their radio service. We have scoped out in broad terms with some former radio sales staff in Blackpool how small amounts of advertising revenue could be sourced to cover the multiplex costs for community groups so, in effect, it would be cost neutral for them. See letter to this effect in Part B.

We have held initial discussions with colleagues in the radio industry regionally who are considering setting up a sales house that would generate an income for stations on small scale DAB multiplexes that carry their advertisements, so that is another potential source of income for our clients. Further, we have engaged with an experienced radio broadcast engineer who lives in the transmission area, and he has agreed that he will provide advice to community groups so they better understand what equipment is required and costs.

We have set out in the 3-year cashflow document a realistic and achievable model for the multiplex operation to be sustainable and for the operators of the radio stations on it to, also, be sustainable. Unlike a private company, if an operating surplus is generated it will be reinvested back into the social enterprise as constituted in the CIC articles of association, and not distributed to shareholders.

Alistair Clarke MBE is a trained journalist and pioneer in the radio industry.

Radio highlights include:

• Employed by Radio Wave in Blackpool – the country's first small-scale radio licence - 6 months before going on air in 1992 to originate and implement the necessary systems to get a radio newsroom from concept to on-air. Alistair remained as news editor for 5 years, setting a blueprint for how small-scale radio stations generate a local news service to engage a local community;

• Employed by Wish FM in Wigan and St Helens 3 months before going on air in 1997 to establish a local news service in a TSA twice the size of Radio Wave and which was heavily focused on rugby league and football. For eight years, Alistair headed a team of journalists generating local news and personally read 20 news bulletins a day;

• Seconded by the parent group IRG to establish a news and sport operation after the successful bid for Wire FM in Warrington and Runcorn in 1998. Alistair oversaw the news operations at Wish FM and Wire FM for 7 years. Regularly dealing directly with the radio group's owner, Kelvin Mackenzie, on individual stories, at management level and on group policy.

For two years, Alistair volunteered – from launch in 2016 – on That's Manchester and arranged and hosted a weekly topical debate on the Freeview television channel.

All news broadcasts in Alistair's 18-year broadcast career were fully compliant with radio broadcasting rules.

Alistair has extensive broadcast experience to be able to advise and train community groups on OFCOM policies to ensure compliance. Alistair holds a BA (Hons) from the University of Westminster in Media, specialising in radio journalism.

After leaving radio, Alistair used his skills in media and marketing to establish a social enterprise to support other voluntary sector organisations. He then trained as a specialist business advisor in social enterprise in 2009.

He is currently the chair of Social Enterprise Solutions CIC in Blackpool which, using a three-year grant from the National Lottery, provides vital support for Blackpool residents in chaotic circumstances in partnership with their GP. He is vice chair of

Social Enterprise Lancashire, Selnet, and hosts its annual flagship awards ceremony for 300 guests.

Alistair is a director of a private company which provides a variety of media services including voice and presentation training news reporters for ITV News when called on.

Alistair was awarded the MBE for services to social enterprise in Blackpool in the New Year's Honours List, 2020.

Tony Carr, born and raised in Blackpool, has been one of the leading lights in the local community of the Fylde Coast for more than 50 years. If successful in the bid to operate the multiplex, Tony will keep a keen eye on the finances.

As a prominent retailer in Blackpool town centre for more than 30 years through the 1970s, 80s and 90s, Tony managed the family business selling high-end ladies fashion and has an enviable track record in marketing and sales. This was an era when Blackpool was synonymous with ballroom dancing with 'Come Dancing' from Blackpool Tower ballroom on television and there was much demand for glamourous dresses.

One of his biggest achievements was establishing and chairing the Town Centre Forum to bring all the shop owners together, which radically improved Blackpool's retail space. This was a forerunner to today's town centre Business Improvement District.

After bowing out at the top on the shop floor, Tony turned his focus to the community initially volunteering at the Citizen's Advice centre in St Annes where he supported people with their social issues such as debt, housing etc.

In the mid 2000s, Tony helped to establish a new social enterprise infrastructure body to encourage more community organisations to start-up and flourish and Tony continues to be the managing director of Social Enterprise Solutions CIC to this day.

Recognition includes:

- Fellow of The Royal Academy of Arts and Commerce (FRSA)
- Fellow of Chartered Management Institute (FCMI)
- CMI Level 5 Award in Management Coaching

Tony was also one of the driving forces in getting Radio Wave onto the air as the UK's first small-scale radio licences in the early 1990s as one of the original financial backers of the bid to the radio authorities and subsequently of the station that formed, Radio Wave (Blackpool) Ltd. He played a key role in raising awareness of the new radio station among the traders in the town centre to ensure that Radio Wave was heard in every shop and café to maximise listenership.

Tony lives with his family in one of the villages in the area served by the multiplex in Wyre Borough.

We intend to launch the multiplex in 6 months from award of licence.

Upon award we will immediately advance negotiations regarding the proposed transmission site(s). In preparing this application, we have contacted organisations based on the Fylde Coast that we believe could offer a real alternative to existing radio services so as to broaden listener choice.

This includes existing online radio stations that are already talking about local issues and are 'oven ready' for moving onto the DAB multiplex and new service providers that could establish stations with information and entertainment for young people, sports fans and minority groups etc or FM stations as the move to digital broadcasting continues.

When we explain to people our passion for providing local services for residents and not just for tourists, the extensive background in broadcasting and community engagement of the directors and our ethos as a company set up without shares so a takeover by a larger group isn't possible, then everybody we have spoken to has offered to support the application. This is more than a bid to operate a multiplex. This is a determination by the local community, both grass roots and public sector level, to bring about a revolution in local broadcasting. As the multiplex is run for community benefit, not to generate a return for shareholders, the directors will not be under pressure to just fill up the space on the multiplex. If successful in the bid, we will set up a steering group of service providers and wider partners to inform and influence decisions taken by the directors. The directors pledge to work equitably with service providers in allocating space on the multiplex and details of rates will be published openly. Should all the space be allocated, we will manage a fair process for a reserve list. If the directors feel conflicted in any way, we can call on other community bodies, like the Council for Voluntary Service, to consult wider with the community.
