1. Introduction

Preface

The Barriers to Proving Age on Adult Sites survey was undertaken by YouGov on behalf of Ofcom. This report refers to the project completed in August/September 2023.

The core objective of this study was to understand and expand on knowledge following Ofcom's research about <u>adult users' attitudes towards age verification on adult sites</u> last year, with a focus in trust on age assurance measures as well as other identified knowledge gaps (e.g. whether VPN or the incognito browsing mode is used when accessing pornographic content online).

The research explores:

- How users access pornographic content online
- Users' experiences of providing their age to access pornographic content online
- Reasons why some users have never proved their age to access pornographic content online
- Current sentiment on age verification and age estimation on pornographic websites or services as well as independent third-party companies
- Factors that influence the likelihood of completing an age check to access pornographic content online

Summary of approach

YouGov is a professional research and consulting organisation, focused on collecting high quality, indepth data for market research and has extensive experience of youth, the television and radio broadcasting sectors as well as on-demand services policy research.

This research was conducted with a sample of respondents aged 16+ who have previously accessed pornographic content online and plan on accessing again in the future.

All research was carried out online, with respondents recruited from YouGov's online panel, containing around 2,668,204 panellists from all over the UK.

A total of 5,242 interviews were conducted in this study. Fieldwork was conducted between 18th August – 14th September 2023.

Significance testing and data redaction

Significance testing has been applied at 95% for the purposes of analysis.

All base sizes below 10 have been redacted/removed from the data tables completely. Base sizes between 10-49 are marked with an * to indicate a low base.

2. Sampling

YouGov interviewed a sample of 5,242 UK respondents aged 16+ who self-reported to have previously accessed pornographic content online and plan on accessing again in future, in order to understand users' attitudes towards proving their age on adult sites.

Fieldwork was carried out between 18th August – 14th September 2023.

The data has not been weighted as the sample fell in line with the demographic profile of X-rated adult site/app users, particularly the skew towards men.

Details of the sample design and research methodology for this study are outlined below.

Sample design

The sample of users was provided by YouGov's proprietary online panel and only those who had accessed pornographic content previously and plan to do so in future was accepted to take part using the following screener within the survey:

Q3. Now thinking about the different websites or services you have used in the past over the internet, have you ever tried to access pornographic content online?

- Yes, and I plan on accessing pornographic content online in future
- Yes, but I do not plan on accessing pornographic content online in future [SCREEN OUT]
- No [SCREEN OUT]
- Don't know [SCREEN OUT]
- Prefer not to say [SCREEN OUT]'

Most demographic information (age, gender, social grade, ethnicity, household income, working status, region) was information declared and collected by YouGov from its panellists as part of the initial signing up process. This information is updated regularly by panellists (every 6 months).

YouGov carried out the following standard checks during and post-fieldwork:

- A manual check post-fieldwork to remove anyone who responded in an unreasonable or suspicious way
- Open end checks to ensure respondents answered thoughtfully and were not spamming answers or bots.
- Ongoing panel quality monitoring and removal of respondents identified as straight-liners from the YouGov Panel.

Quotas

Interview quotas were applied so that the final sample allowed for n<150 responses for analysis for the following age groups: 16-17, 18-24, 25-34, 35-44, 45-54, 55-64, 65-74, 75+.

Quotas were also applied to skew towards male to match the usage profiles of X-rated adult site/app users.

Fieldwork

All interviews were conducted online between 18th August – 14th September 2023.

Due to the sensitive nature of the research topic (e.g. questions related to accessing pornographic content), respondents were forewarned and asked to give their consent to participate, in line with MRS guidelines. Questions related to sentiment towards age verification and age estimation on pornographic websites/independent third parties that were asked as part of the research were suppressed for respondents under 18. Furthermore, a question relating to VPN usage to access pornographic content was amended for respondents aged 16-17, so that the survey did not inadvertently promote usage of VPN to access pornographic content to under-age respondents.

To test consumer understanding, we included self-declaration methods such as "enter my date of birth" and "tick a box or click a button which asks whether I am 18+" when respondents were asked what methods they used to prove their age to access pornographic content. However, Ofcom do not consider self-declaration as a form of age assurance therefore self-declaration would not be considered as a method for proving age under the Online Safety Act.

Definitions of age verification and age estimation used in research:

Age verification is determining whether someone is aged 18 or above by verifying their exact age. Examples of age verification methods include verifying someone's:

- Credit card details
- Online banking details
- •Identity documents (e.g. passport, driving licence, ID card, birth certificate or similar) It does not include age check methods such as ticking a box to confirm someone is 18+ or entering a date of birth.

Age estimation is determining whether someone is aged 18 or above by estimating their age or age range. Examples include someone uploading or scanning their face, or speaking with their voice to get an estimated age.
