I believe that the introduction of pricing for VHF frequencies used by GA (General Aviation) will result in many small airfields and clubs abandoning their A/G radios making the UK airspace more dangerous. To have priced an A/G frequency the same as that used at a commercial airfield is nothing short of a tax on those of us who enjoy aviation as a hobby. Already frequencies are "shared" between airfields, albeit they

are so far apart as to be non interefering.

Since all aviation users, both ground and airborn stations, already pay a licence fee why do we need yet more fees?
