This response is from the point of view of someone who watches quite a lot of TV, but very little of it live, and exclusively uses home made media centre built from standard PC components running the open source PVR system called Myth TV on a Linux operating system.

Fundamentally - if you let the BBC do this - I'm screwed.

Question 1: Do you agree that copy management would broaden the range of HD content available on DTT and help secure its long term viability as a platform? :

Absolutely NOT.

Question 2: Do you agree that the BBC's proposed multiplex licence amendment represents the most appropriate means for securing an effective content management system on HD DTT? :

Absolutely NOT.

Content management is simply not the right way to address copyright violations. It is akin to assuming I am guilty until proven innocent.
