C.I. Broadcasting originally proposed to OFCOM that a SSDAB licence for the Scottish Borders be identified and advertised. Although OFCOM have used our Expression of Interest and associated transmitter plans as part of the expansion of SSDAB plans, they have not yet advertised this licence, partly, we believe due to the objections of existing FM broadcasters in the Borders area. This unfortunately means that the Scottish Borders remain one of the few DAB 'white areas' within the UK.

Accordingly we were interested in operating the adjoining area of planned SSDAB licences, and when Alnwick and Morpeth was advertised, we realised this could dovetail nicely into our corporate plans for the future. A number of prospective stations and service providers were already known to us, and we believed that the Alnwick and Morpeth area could be financially viable and also affordable to small scale users.

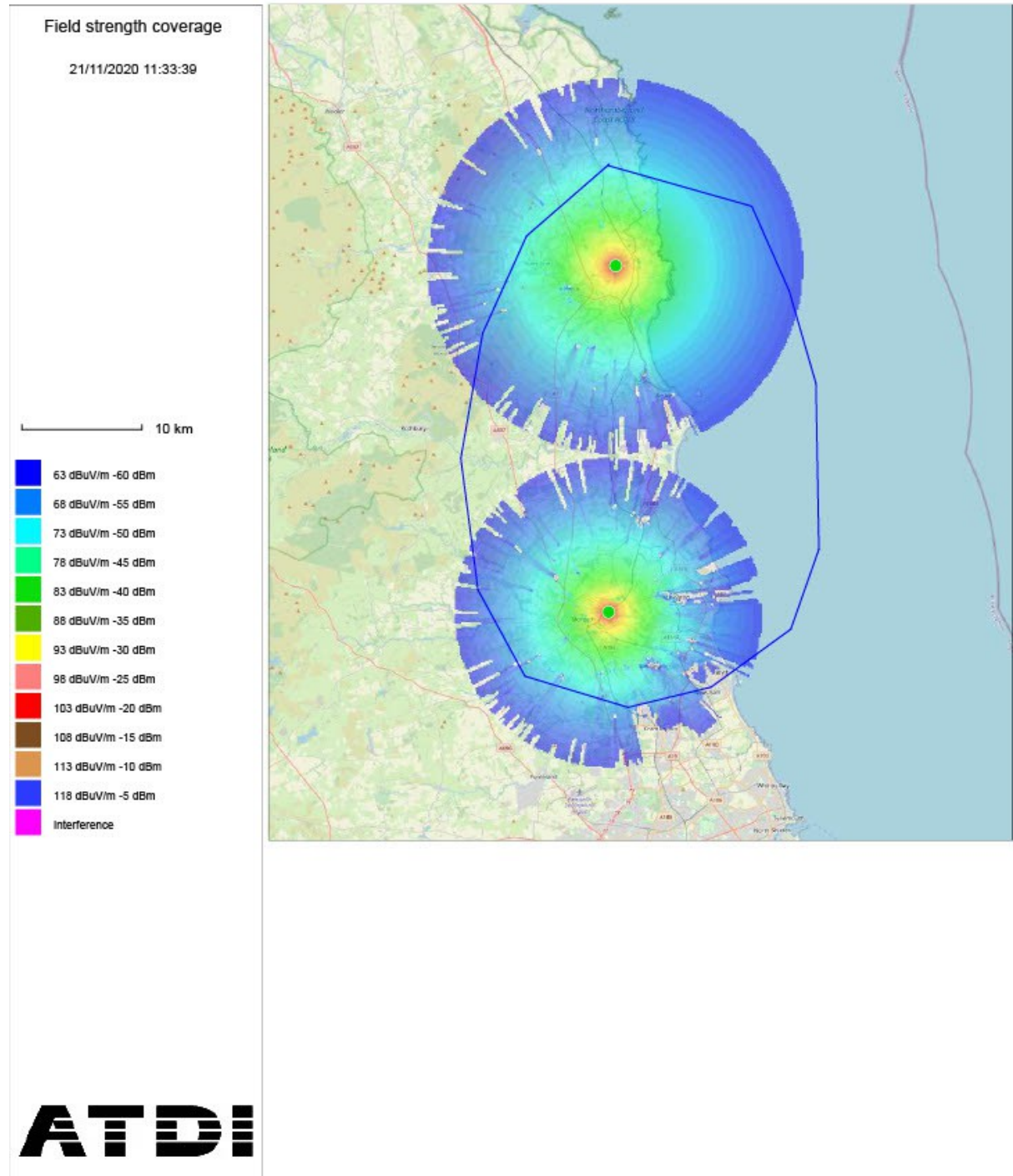
On first inspection of the proposed coverage area of Alnwick and Morpeth, it seemed that OFCOM were proposing coverage in line with a single centrally sited transmitter, and we did explore that option. By using a single transmitter at Shilbottle, roughly in the centre of the proposed OFCOM polygon, we could achieve reasonable coverage, however the power levels required were considerably more than the upper limit of 200w that OFCOM are allowing at this

time.

Accordingly after several visits to prospective sites we settled upon a small SFN network of two transmitters. One at Peppermoor Farm, to the NE of Alnwick and the other being the Arqiva DAB site to the east of Morpeth. Using HTZ plotting software we were able to achieve reasonable coverage at the 63db level using c. 200w ERP levels from each transmitter. To give rock solid 63db coverage within the whole area, we would have required the use of a third transmitter site at Swarland to the south of Alnwick on the A1. Approaches were made to the site owner, but a third set of transmission equipment would not be viable. In actual fact the whole area should receive a strong 54db signal which is more than adequate for all cars and outdoor mobile devices.

The principal areas we will be serving are the population centres of Alnwick and Alnmouth in the north of the area and Morpeth, Ashington and Blyth in the southern end. As we plan to use omni-directional antennae at both sites there will be a slight overspill from the Alnwick transmitter to the north of the advertised area, however this is mainly a rural area with only Seahouses being a town of any size that might be served by a usable signal. To the south we do not expect any significant signal overspill at the 63db level outside the advertised area. We believe Cramlington and possibly Ponteland will be at the southern extremity of the available signal.

Financial and business plan

- 3.24 Explain how the applicant considers it will be able to establish its proposed service. This should include an explanation of the costs required to establish the multiplex service, and how these costs will be met:

Due to the large geographical area to be covered the multiplex will have to consist of a multi transmitter Single Frequency Network. We explored the possibility of using a number of different sites, including using a single transmitter at the Arqiva Shilbottle site which is in the centre of the proposed area, however the ERP levels required were not available under the OFCOM application guidelines, which would have required an ERP level of c. 1kw, outside of the proposed upper limit of c. 200w. In the end we settled on 2 transmitter sites, Peppermoor Farm and Morpeth as giving us the best coverage area, with as little overlap as possible into the neighbouring southern SSDAB licence areas of Newcastle and Tynemouth/South Shields.

Morpeth is a current Arqiva DAB and TV site, and we have been in talks with our existing Arqiva account manager concerning using this site, and we have received confirmation that space is available on this mast, and we have received an indicative reference offer price for placing services there.

Peppermoor Farm is an ex Arqiva site (DAB) that was purchased by On Tower Ltd (Cellnex) last year. Again Cellnex have indicated space is available and we are currently in commercial negotiations regarding mast rental charges.

It would be ideal to have had a third transmitter sited between the two main transmitters to increase the power of the SFN, but the benefits were outweighed by the additional capital cost. Although OFCOM have stated that they will not entertain additional transmitters in a SSDAB licence area, unless noted in the original application, we would hope to revisit this scenario in 2 to 3 years time.

Through our preferred suppliers; Factum Radioscape, TransplanUK, and Lucoro Broadcast, we have received accurate capital and ongoing maintenance quotes. The capital equipment budget for the transmitter sites is £20,000 to include 2 x TX-DAB200 transmitters, 2 x Colinear RVC6 antennas, 2 x Delta Mechanica filters, 2 x GPS antennas, 2 x Insert points and 100m of RG8 Cable. Due to the nature of the installation work a budget of £5,000 has been allocated to install equipment, including mast climbing.

The capital costs will be financed by a commercial loan from Small Digital Planet Ltd with the Heads of Terms having the following details: £30,000 loan over 5 years repayment @5.5% interest. Repayments of £571 per month. Loan secured on transmitter equipment.

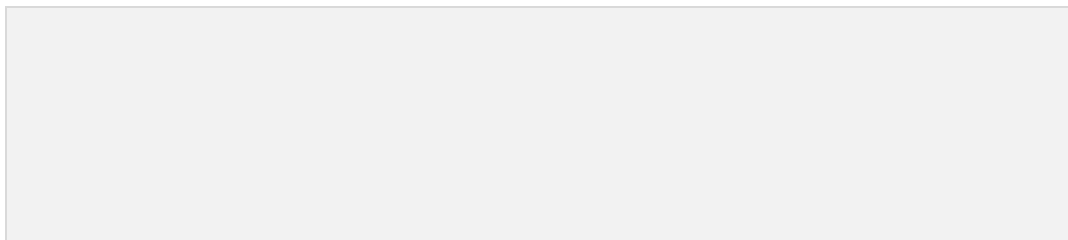

Spencer Pryor will be responsible for the day to day management of the multiplex service. He has been involved in Small Scale DAB since the inception of the trials in 2015 as one of the original licencees. He sold his broadcasting interests, which included FM commercial licences and the SSDAB Glasgow licence to Nation Broadcasting in 2018 planning to retire. He was asked to continue to work as a consultant and main point of contact for Nation for their Scottish interests which he has been doing since that date, overseeing FM and DAB transmitters and their general day to day operation.

He has a lot of experience in station liaison having increased the number of stations on the Glasgow Trial Multiplex from 4 at launch to 24 when he sold his interest in the multiplex. Coupled with this has been detailed admin work during the operation of the multiplex concerning regulatory matters such as obtaining SID codes and DSP licences for prospective broadcasters, coupled with numerous Change Requests to OFCOM concerning the operation of the trial mux.

Using Asana Project Management Software, the roll out plan is completed. GANTT chart attached as file A&M Multiplex Asana2.pdf. Timings depend on the date of award of the licence. From experience we would estimate that OFCOM will make the awards around the end of February 2021.

The two key concerns then are the finalisation of mast rental contracts with Arqiva (we are already an existing client) and the entering into a formal contract with Cellnex for carriage on Peppermoor Farm. Initial credit checks and account opening applications with Cellnex are already underway.

Arqiva insist on a minimum 6 month installation process from date of contract signing. We hope that Cellnex are a little more flexible. We envisage installation at Peppermoor Farm to be around September 2021 with commissioning checks by OFCOM shortly after. We would hope to be on-air in October 2021 at this site. Arqiva taking longer to commission and install we would hope to be on-air by December 2021, with the whole network operational as an SFN at that date.

These time frames have been agreed as feasible with our installation and commissioning engineers Transplan UK.

Station Service Provider Carriage Agreements will be formally confirmed during the summer of 2021. We are not unduly concerned with gaining additional new service providers during this phase. Experience in the launch of the Trial Glasgow mux was that we went on air with just 4 service providers rising to 26 over the course of 18 months. A lot of experience has been gained in the practicalities of launching a SSDAB mux during that time period, and this knowledge will be used in the building and operation of this mux.

General information concerning C.I. Broadcasting's application was publicly made on the 6th November 2020 when we invited 'expressions of interest' from potential service providers to register their requirements for taking carriage upon the Alnwick & Morpeth multiplex.

We had previously been holding myriad discussions with a number of operators, details of which are contained in Part B of this application, including a number of stations that must remain confidential at the time of the application.

At the date of the application the following line up of stations in the bouquet has been agreed:

C-DSP Licences.

Lionheart Radio , Alnwick, C-DSP (TBC) - Current Community FM station within area.

KOAST FM, Ashington - C-DSP (TBC) - Current Community FM station within area.

Nova Radio NE, Newcastle - C-DSP (TBC) - Current Community FM station within postcode area.

Pride Radio, Newcastle – C- DSP (TBC)– Current FM Community FM station within postcode area.

Radio Northumberland – C-DSP (TBC) – Unsuccessful FM applicant in last FM licence round.

DSP Licences

Nation Radio UK – DSP – Current DAB operator in London, planning to go UK-wide

Nation 80s – DSP – Current DAB operator.

Chris Country – DSP – Current DAB operator aimed at Country Music listeners.

Timeless Radio – DSP – Current DAB licenced station aimed at Easy Listening listeners.

Radio 31 – DSP (TBC) – Current online evangelical Christian radio station based in Scotland promoting family values.

SUN FM – DSP (TBC) – Current FM commercial station for Sunderland and NE England.

At launch we expect to have around 18 stations broadcasting. At the present time we have only requested non-binding Letters of Intent from stations wishing to broadcast.

5. Fair and effective competition

About this section

C.I. Broadcasting proposes to act as a 'gateway' operator in respect to fair and equal access to carriage upon the Alnwick & Morpeth multiplex. From experience in running the Glasgow Trial multiplex there is a consensus of opinion that we operated access to the multiplex in a fair and equitable way, with nobody being refused access if they had a valid OFCOM DSP licence. As a Trial short term licence in Glasgow, we were more interested in proving the technical proof of concept of the multiplex, rather than the financial success of the Trial multiplex, and accordingly service providers paid between £50 and £200 a month dependent on charitable/commercial status, and the amount of CU's each provider used.

For the Alnwick & Morpeth multiplex we intend to continue the availability of access to nearly all-comers. The principal criteria is that the Service Provider has a valid C-DSP or DSP licence from OFCOM. It has been decided that carriage costs will be based on capacity and as an indication we expect a median price to be around £200 per month for carriage on the SFN multiplex. We have also decided that the regulated C-DSP slots (5) will be offered on a first come first served basis to licenced C-DSP service providers within the NE postcode area on a no carriage fee basis for the first 2 years of operation and then at a 50% discount on ratecard price from Year 3. Unlike other prospective operators we propose that our Carriage Agreements do not have a long term 'lock-in' period, enabling Service Providers to give us 6 months notice at any time should they wish to withdraw from the mux.

Due to the relatively high number of regulated Capacity Units on this multiplex (5 stations) we believe that around 22 services consisting in the main of 32k DAB+ services will be the practical limit

on this multiplex. A waiting list would then be introduced for prospective broadcasters if full capacity is reached.


