Overview

- What is the target community of the service? Please include the geographical area that you

- We intend to offer a full community radio service to people who live, work and visit geographical area of Biddulph and the surrounding areas of Leek and Congleton. Areas of Biddulph are within the Stoke SSDAB service area. We intend to continue our coverage to these areas of the town we are based in, as well as the surrounding area of Staffordshire Moorlands and the Cheshire borders around Congleton, recognising the established links between these areas and our target audience in Biddulph, related to culture, work and leisure.

Whilst we wish to serve all members of the community, we are particularly focused on the issues of social isolation and rural deprivation. We don't just intend to work with a wide range of community organisations in order to do this; we are already doing so and have an established track record of success. As a fully – operational online station we already have a demonstrable record of working with

the likes of Biddulph Youth Community Zone, the Local People's Project, New Era Victim Support, Old Sawmill Community Cafe, Staffordshire Trading Standards, Local NSPCC, Samaritans, Staffordshire Breast Cancer Support and Biddulph Town Council amongst others as broadcast partners.

- We have made sure our studios are disability compliant and fully accessible and for this we are indebted to our volunteer coordinator, who is himself registered as seriously visually impaired and to Biddulph Town Council who have gone out of their way to support us in this community enterprise, not least by providing premises within the Town Hall which have enabled us to provide an accessible, high profile and practical base for our operations.
- Our intended community 'patch' for this multiplex is the border area of the Moorlands and Stoke- on-Trent with areas such as Biddulph & Knypersley and Werrington which are parts of the Staffordshire Moorlands but are included in the Stoke multiplex polygon. We are of the community as well as operating within it. The station will always prioritize local people's interests in terms of output, and will also prioritize the input of local people when it comes to staffing and running the station. The station is already cemented in the community and for the community and this is why it has received the support it has in the stated aim of providing a SSDAB option for local radio listeners. We are delighted to have been presented with this opportunity to apply for such a licence.
 - How will you ensure that your proposed C-DSP service is run on a not-for-profit basis?

 - In the first instance the company has been set up as a CIC as can be seen from the Companies House records. As you will be aware, this structure removes the opportunity for individuals to profit from such as enterprise and effectively obliges the directors to full disclosure of the distribution of such profits. This is in accord with our stated aim of running the station as a community organisation which is avowedly not driven by the profit motive and all that such a motive necessarily entails. The relatively modest amounts of capital expended at setup and the small shareholdings involved are another indication of this.
 - All our staff are volunteers and we cannot foresee circumstances where they will not be.
 - As an example of how any profits after running costs are covered will go towards developing the service and adding significantly to social gain, we have already developed a basic broadcast studio training facility which we offer to schools for use with school holiday activity packages and other training opportunities within term

- time. Necessarily this will entail compliance training of various kinds and this will also be funded from any profits made by the CIC, as will future equipment purchases to improve our existing OB equipment, for example.
- And we would stress at this juncture that this is happening NOW. This is not merely an aspirational statement; this is a statement of actions already taken and currently in train by an organisation which is always looking to be of service to the community from which it sprang and the needs which that community demonstrates. This is already a community broadcast organisation in action; for it to develop and grow, it needs access to a free to air conventional radio platform. We are very aware the reserved 'community' channels on an advertised multiplex are a rare and precious commodity. We respectfully request that to help boost the value of these channels to the community that our application is given serious consideration as we are already demonstrating what CAN be done in our area.

Social gain

- What community benefits will your service bring to your target community(ies) and, if applicable, the general public. - For this we would be obliged if you would refer to the file of supporting materials we have provided for your perusal. This is just a small sample of those organisations and individuals who we will be delighted to work with to provide positive outcomes within the community. Mindful of your stipulation to avoid 'naming names' in our answer we will only refer to organisations and groups rather than individuals.
- As already mentioned our specific focus will be on social isolation and rural deprivation. We will try to give much support as possible to those organisations which, on a local level, strive to support and nurture mental health and general well being. We've already listed a number of organisations which we would class as broadcast partners; they regularly supply us with interview guests and have virtually open access to listeners via Churnet Sound. These include Biddulph Youth Community Zone, the Local People's Project, New Era Victim Support, Old Sawmill Community Cafe, Staffordshire Trading Standards, Local NSPCC, Samaritans, Staffordshire Breast Cancer Support and Biddulph Town Council but there are many more. We have interviewed representatives of all these organisations already via our online service and will continue to offer such opportunities if granted the opportunity to access reserved space on the Leek Congleton multiplex.
- We Broadcast from within the Community Centre, Biddulph Youth and community zone and promote and support their work in some of the more deprived areas of the Staffordshire Moorlands. We also help to promote the regeneration of the coalfield area.
- We also offer formalized and programmed opportunities for the promotion and support of these organisations. We have integrated regular 'Community Matters' spots within each hour

of peak time programming (7am-7pm), promoting calls to action from our broadcast partners, be it in the form of volunteers, donated goods or the raising of awareness of services offered to local people – indeed anything short of direct appeals for cash. We also offer the 'Community Noticeboard' – a free 'What's On' event listing for charitable and community organisations to promote forthcoming community events and happenings. In designing this into our programming, we have enlisted the help and support of two of the former directors of ILR station High Peak Radio Ltd, who pioneered this method of supporting local community organisations at no cost to themselves. This will be of demonstrable use to both to those organisations but also to those who need to access their services. These services will simply be transferred across to the SSDAB service should we be given the opportunity to do so.

- As already mentioned we have built a mobile training for use in schools and colleges and if
 offered access to the reserved area on the SSDAB multiplex for the area, we will extend our
 rollout of this aspect of our offer to the community to involve after school clubs and holiday
 club activities.
- We broadcast appeals for local people to join the Churnet Sound team as volunteers on a regular basis and we feel that opportunities to be involved with an OFCOM – regulated broadcaster with a track record in offering a warm welcome and ease of access is one of the main 'value added' items we can contribute to social gain.

 - We will facilitate discussion and the expression of opinion through a number of our programmes. One example of how this will be achieved is our highly rated LGBT show. Presented by a member of the local council, it is typical of the ways in which we expect Churnet Sound to be representative of ALL members of the local community and typical of the inclusivity that we wish to promote. On a contrasting note, discussions involving local people on matters of local importance, for example the coronavirus pandemic and the effectiveness of local services in responding to this has been welcomed and in some cases celebrated.

Guests from all walks of life representing a range of perspectives are always welcome to express themselves on Churnet Sound but we are very aware that from moving from online only to SSDAB we will fall under the regulation of OFCOM and that whereas the station management has extensive experience of working with OFCOM regulated broadcasters, some of our team will not be in that position and so we undertake to organize effective training in awareness of the broadcast codes.

How will you ensure that members of your target community(ies) can gain access to the
facilities used to provide your service, and receive training in using these? In particular, please

Our central position in one of the area's main towns and the accessibility of the studios for all (as a community centre, the building has been assessed for accessibility for people with different types of disability and limited mobility) means that we are physically easy to access.

We are within a very short distance of local bus services and are in the middle of one of the area's biggest centres of population, albeit in a region of generally low population density. We are 'surrounded by chimney pots'.

On air, we broadcast numerous appeals for volunteers and all our staff are encouraged to go out of their way to present a welcoming and friendly face to anyone who visits the station.

We operate a policy of reaching out into the community and already have an excellent track record of taking part in community events and we intend for these to continue and develop if we are given the opportunity to serve the community on reserved capacity on the proposed local multiplex. For example, we took a stall at the Biddulph Artisan Market recently, and were Official Partners to Leek Show in 2021. We have interviewed and frequently feature local Patient participation groups and every month hear from a leading pharmacist from the Clinical Commissioning Group for Staffordshire. We have strong links with the Rudyard Lake league of friends and regularly do live shows from the lakeside to promote the charities actions

Practically, as well as a fully – functioning on air studio, we have a full studio 2 setup which enables interviews to be recorded off air and played out later. This also functions as our training studio and we have been involved in training on our state – of – the – art Myriad play out software not only for our own station but also for other stations as well. Not only this but because of the system's ability to function via an 'Anywhere' facility, it is possible for some presenters and programme contributors who for whatever reason cannot make it to the studio, to STILL be able to make recorded and live contributions to programming and we feel this will become and increasing advantage in an area with a number of remote and inaccessible locations, especially during periods of adverse weather and such as the difficulties of access brought about by the COVID-19 pandemic.

During School Holidays we have worked with both Staffordshire County Council and Cheshire East council to provide activities and food for free to children who are in receipt of free school meals as part of central governments HAF scheme.

 How will your service provide better understanding of your target community and the strengthening of links within it? Answer in fewer than 200 words.

The community programming features already mentioned cannot help but do this by promoting the aims and offers made to local people by those organisations but our continuing attempts to reach out to the community and to offer help, support and in some cases to shine a spotlight on our community's positive efforts to support itself need to be mentioned here. Hosting the 'My Voice' Youth Awards is an important example of this and helping to celebrate the achievements of young people in our area; also in hosting the Support Staffordshire Volunteer Awards. Not only are we an organisation which is pleased to be 'made of' volunteers; we are happy to celebrate the function and role of the volunteer generally in our local area.

Our mobile training studio is regularly visiting schools and community centres, will, via training, enhance team building, language skills, social development and tap into the school curriculum via such strands as History and local Geography We have also been successful of

offering free half term activities to children who receive free school meals on behalf of both Staffordshire County Council and Cheshire East Council.

Matt Hill (Director) has extensive experience working with community organisations in arranging on-air opportunities and preparing them for making contributions to programming via his work as a director of local community station Moorlands Radio from 2015 – 2021. Joe Pointon (Director) has experience of training and working with teams of volunteers on the local heritage railway, Churnet Valley Railway as well as with volunteers for Churnet Sound. Both have participated in the Christmas lights 'switch – ons' organised by the local councils during the last few years.

Participation

- All volunteers are members of the target community. Both on air and via the website, local people will be left in no doubt that they are needed and will be welcomed in order to help the service succeed in the aims it has. Particular volunteer roles will be made explicit and the offer of training will, as ever, be at the heart of these opportunities. Volunteers tend to bring a range of skills and experiences and it is with this in mind that we aren't looking for a bunch of itinerant disc jockeys; we're looking for accountancy and office experience, people who are effective on the phone; people with a background in sales; people with experience in the voluntary sector in terms of training and accessing grant aided funding. We'll welcome potential trainee journalists from local colleges; encourage schools to place us on their list for potential work experience placements once we have the relevant safeguards in place to do so.
- Above all else we recognise it is necessary for the continued development of Churnet Sound for us to stay true to the above. There is always going to be rotation in volunteer staff; people will move on, they will opt to do other things having gained a degree of enrichment, either in terms of skills, social development or experience, here at Churnet Sound. And so we will need to be constantly accessible, approachable and welcoming to ALL members of the local community if we ourselves are to thrive and flourish as an organisation.

 We continue to do outreach work with schools and community organizations in the form of our radio workshops

- Technically we aim to make contact as easy as possible and offer a range of choices in terms of method. We will have a text line directly to the studio and a studio e mail address and encourage phone calls to our dedicated app. We will instigate a monthly director's review to discuss issues raised and where relevant, take action as a consequence. We will also actively explore local interest in the possibility of setting up a listener's panel to see if this gains popular support.
- Most importantly we will use our website to ensure that these methods of contact are easily available and are just a click or call away and the contact details will always be prominently displayed on the website. The use of an eye catching logo and area name has already worked wonders in establishing local broad recognition and regular on air 'plugs' for the website and the specific 'ways to get in touch' are bound to encourage the notion of ease of access and transparency.
- And once again the point we would seek to establish is that these are not lofty claims or 'pie in the sky'. The technical means to contact us that we have mentioned ALREADY EXIST via the structures we have put in place to serve the online station which is already streaming with great success. The framework for this is already tried and tested, we already have access to the domain names and the e mail addresses; in this respect we are all but ready to go already.
- We constantly speak with and meet members of the community we serve and allow them to make comment which is then listened to to shape our service. During business hours our studio operates an open door policy and all members of the community are welcome to visit.
- How will suggestions and/or criticisms from members of your target community(ies) be considered and acted upon? Answer in fewer than 300 words.
- To begin with, we are already logging output in respect of the online station in line with OFCOM requirements so in the event of a complaint, we are already complying with the regulator's requirements to record output; so evidence provision is already a given.
- Directors are ultimately responsible for the station's output and so are responsible for answering any complaints and will undertake to do so in terms of an initial response within seven days of a written complaint being made. They will then consider the implications of the complaint and this will take a variable amount of time depending on the nature of the complaint.
- Suggestions and criticisms are of course a different matter and the regulator normally has no
 role in these. However, this doesn't mean they are not important to local listeners and so the
 directors undertake to respond to such messages also within seven days barring force
 majeur. Suggestions and criticisms often form the bedrock of positive programming ideas and

Compliance is also a major part of initial training of Voluneteers

If a presenter was to breach any of the Ofcom or Internal policies or rules they would be remove from our schedule with immediate effect and subject our disciplinary policy. A full investigation would follow and would not be allowed on air until the investigation was concluded.
