

**Response to “Future of telephone numbers – 1 Dec 2023”**

The important issue of the continuing use of 084 / 087 numbers has been dropped from the list of topics on which Ofcom is now consulting.

As will be understood, this is of great concern to the **fair telecoms campaign**.

By way of response, I offer a copy of a media release being issued today, which may contain points of some relevance to the “future of numbering” team, from which I am sadly now totally disengaged.

A copy of the media release follows.

I am content should Ofcom wish to publish any part of this.

**Ofcom allows the 084 / 087 rip-off to continue**

The **fair telecoms campaign** has long been pressing for misuse of 084/087 numbers to end.

In 2019, **Ofcom** proposed to cease use of these ranges¹, subject to any possible suggestion that their use could ever be valid. We note however that no such responses to the relevant consultation were published, whereas support was provided from many respondents².

Ofcom has rightly noted that use of these ranges has diminished significantly over recent years, in all cases due to measures related to the campaigning efforts of the **fair telecoms campaign**.

We are however very disappointed that, without giving any reasons for this decision, **Ofcom** has decided that use of these ranges may indeed continue. A consultation on related matters³, with no reference to the possibility of ceasing use of the ranges, does however close today.

Now is perhaps a good time to update our lists of particularly poor cases of misuse. These cover:

We are delighted to see that 66 of the 99 organisations featured there are no longer advertising 084 / 087 numbers on their websites, but disappointed to find that the 33 listed overleaf still are.

In the absence of appropriate action by **Ofcom** we are left to resume our campaigning efforts on this topic. This will have to include updating and strengthening a release we issued at the time of the initial **Ofcom** proposal in 2019, which is now abandoned - [Now is the time to stop using 084 and 087 telephone numbers](#).

These organisations levy a “Service Charge” of up to 13p per minute on callers to the declared numbers. Because of this premium, callers also incur an Access Charge, to the benefit of their telephone service provider, of up to 70p per minute.
