1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a Community Digital Sound Programme (C-DSP) licence.
- A digital sound programme service intended for broadcast by means of a local or small-scale radio multiplex service requires either a C-DSP licence or a local DSP licence. Ofcom's published guidance notes set out some of the key issues that potential applicants need to consider in deciding which type of licence is suitable for them. In summary, C-DSP services are not run for financial gain and are required to provide social gain. C-DSP licences therefore include strict conditions to ensure that happens, and provide less flexibility than a local DSP licence. However, they do provide access to capacity that small-scale radio multiplex service providers are required to reserve solely for C-DSP services.
- 1.3 A C-DSP licence will be required even if the same programme service is also provided on any other platforms (e.g. FM, satellite), as separate licences are required for those.
- As noted above, small-scale radio multiplex services will have reserved capacity for C-DSP services. Issue of a C-DSP licence does not, however, guarantee carriage on a small-scale (or local) radio multiplex service. That is a matter for agreement between the C-DSP licensee and the multiplex service provider, and there may be more C-DSP licences issued in a locality than there are reserved slots on the small-scale radio multiplex service. Note that a C-DSP service does not necessarily have to broadcast using reserved capacity. It can use unreserved capacity on a small-scale radio multiplex service or capacity on a local radio multiplex service, again subject to agreement with the multiplex service provider.
- An application for a C-DSP licence will be accepted only once Ofcom has advertised the licence for the small-scale radio multiplex service upon which the proposed C-DSP service is intended to be provided. There is no closing-date by which an application for a C-DSP licence must be submitted (i.e. it can be submitted at any time after the licence for the relevant small-scale radio multiplex licence has been advertised).
- You can find further information about how to determine if a service requires a C-DSP licence in Section 2 of the <u>guidance notes for applicants and licensees</u>.

Provision of information

- Ofcom requires complete and accurate information to assess applications. African Voices aims to serve the African and African-Caribbean diaspora in Sheffield and Rotherham. Target groups include long established communities of African and African-Caribbean cultural heritage as well as more recent migrants and refugees. For example, the first generation of Somali immigrants came to Sheffield in the 1930s, mainly to work in the steel industries, with numbers increasing in the 1950s and 1960s. The Somali Community and Cultural Association (ISRAAC) was established in 1981. After the outbreak of civil war in Somalia in 1988 a new generation of Somalis arrived in Sheffield many with family connections to the city. More recent conflicts and political repression in countries such as DRC, Sudan and Zimbabwe, among others, have brought new refugee arrivals to Sheffield, which is the first UK city to declare itself a "City of Sanctuary" for asylum seekers and refugees. Many in the African-Caribbean communities of Sheffield and Rotherham trace their heritage through the transportation of the Windrush generation of post WWII arrivals. The Sheffield and District African Caribbean Association (SADACCA) was established in 1986 having emerged from the earlier West Indies Association formed in Sheffield in 1955. Sheffield is also home to two major universities with significant numbers of international students and research staff including from Africa and the Caribbean.

The target geographical coverage is within the coverage area of the multiplex service.

African Voices Platform C.I.C. is a not-for-profit community interest company limited by guarantee. The objects of the company are:

- "1. To promote social inclusion for the public benefit by supporting the development and distribution of high-quality, non-commercial media content and services with particular attention to the needs and interests of the African diaspora and migrant communities, diverse audiences, and unserved and underserved communities and the public generally.
- 2. To promote racial harmony particularly the mutual understanding between different racial groups by promoting community engagement through media production of niche content in racially diverse communities, to encourage understanding and compassion and combat discrimination and prejudice."

As a community interest company limited by guarantee the organisation has a statutory asset lock, set out in Article 2 of the Articles of Association, which states that the transfer of assets other than for full consideration, may only be made to a similarly asset-locked body or for the benefit of the community (other than by transfer to an asset-locked body).

In the case of dissolution the Articles of Association (Article 15) provide that any assets remaining be transferred to one or more other asset-locked bodies with similar objects or applied directly for the objects or for purposes similar to the objects.

Social gain

African Voices Platform was formed in 2018 and registered as a community interest company (CIC) in 2020. It produces weekly programmes for local TV and community radio in Sheffield and has managed a number of community projects in pursuit of its objects including providing targeted public health information during the Covid pandemic.

Community benefit is central to our mission and embedded in our CIC objects.

Our aims in establishing African Voices are, in particular:

- To educate, empower and enlighten our communities
- To raise awareness and understanding of issues pertinent to our communities
- To create a platform where these communities can have their voices heard and understood
- To give an opportunity to our young people to learn new skills and be able to serve our community

We will achieved these aims through multiple activities, both on air and off air, including:

- Delivering a 24/7 community radio service for target communities of the African and Caribbean diaspora, carrying diverse music genres and a range of speech and magazine programming including in English, French and community languages.
- Engaging and supporting volunteers including providing induction, training, production support and access to facilities (studios and production workstations)
- Supporting community events and festivals through broadcast coverage.
- Collaborating with community organisations to develop and host programmes corresponding to the diversity of our communities' tastes and interests.

We have been supported in the formation of our organisation and the development of activities by Sheffield Local Television, which operates Sheffield Live TV, and by Commedia Sheffield, which operates Sheffield Live community radio. We will continue to draw on this support to develop African Voices as a community digital sound programme service.

3.8 Please summarise how your service will facilitate discussion and the expression of opinion.

We will carry a range of speech-based programmes that encourage discussion and expression of opinion on issues of local, national and international importance, including with studio guests and with opportunities for audience feedback on social media.

These will include programmes focussing on culture, human rights, health, community development and current affairs, among others. We will include debate, discussion, audience participation and expert opinion on issues relevant to our communities including current affairs in Africa and the Caribbean, as well as local and national news.

3.9 How will you ensure that members of your target community(ies) can gain access to the facilities used to provide your service, and receive training in using these? In particular, please set out how this will be done practically, formally and/or informally. Answer in fewer than 400 words.

We operate African Voices Platform from centrally located public access premises hosted by Sheffield Live with radio studios and other facilities available to volunteers. The centre is easily accessible and located in the heart of the community. We will also organise workshops, training courses and other events at community locations with links to our target communities such as ISRAAC and SADDACA.

Our core team will provide induction, training and ongoing support to enable effective use of facilities by our community volunteers for live broadcasting and pre-production. The facilities available include computer workstations for editing and programme preparation. We will also provide access to portable recording equipment for interviews etc.

3.10 How will your service provide better understanding of your target community and the strengthening of links within it? **Answer in fewer than 200 words**.

We will promote better understanding of our community through the diversity of our programme output, including diverse genres of music, providing a platform for community talent and cultural expression, encouraging dialogue and listener engagement on community issues, and improving access to local information. We aim to contribute to community cohesion and strengthening of community links through a diverse range of music and speech programming that highlights different interests, cultures and experiences and promotes cross-cultural awareness, understanding and engagement.

3.11 Please summarise the relevant experience of the group or its members in activities related to the provision of social gain or other relevant non-broadcast areas (such as third sector, training or education). **Answer in fewer than 200 words**.

African Voices Platform has managed a number of community projects to promote health and wellbeing, community engagement, empowerment and access to information. Alongside the broadcast service we will continue to develop and deliver projects that are of wider community benefit working with community organisations, local authorities, health services and other stakeholders. The broadcast service will enable us to increase the reach and impact of such projects and to grow and sustain our wider community activities.

Participation

We have an open and accessible volunteering policy to enable members of the community to participate and contribute to programme making and management of the service. Around 20 volunteers are involved on a weekly basis all of whom live in or have connections to the local community. We encourage volunteering and welcome offers to volunteer whether in production or in other activities, including administration, security, caretaking, technical maintenance and social media management. Volunteers interested in programme making are encouraged to join existing production teams or to develop their own programme proposals that can contribute to our objectives. New programme-making volunteers are supported with induction and short courses in radio production skills (hardware and software) including issues of compliance with broadcasting regulations.

Accountability

Members of the community can contact the service by email, telephone, post or social media. We welcome comments and feedback and endeavour to respond promptly to any complaints. Members of the community are able to get involved as volunteers, to participate in training courses and to join as members of the community interest company. We have an open membership, including volunteer members and supporters. We hold consultative meetings with the members and we encourage public feedback through phone-in programmes, social media, surveys and open workshops.

Handling of suggestions and criticisms, including listener complaints, rests with the board of directors. The compliance officer holds a BA degree in journalism from Sheffield Hallam University graduating in 2014. The degree course covered broadcast and print journalism including modules on media law, broadcasting regulation and broadcasting code.

The compliance officer has also received on the job training and mentoring in broadcast code compliance as a news journalist and producer with Sheffield Live radio and TV.

The compliance officer has ten years experience as a freelance journalist in broadcast, print and online media. He worked with British Muslim TV 2014-15. He joined Sheffield Live TV in 2014 where he has worked as a news journalist on the daily broadcast TV news programme and later, from 2018, as a producer and presenter for the community affairs TV programme African Voices. He founded the African Voices radio show in 2021 which broadcasts on Sheffield Live community radio. He also has previous experience in print and online journalism working for the Paris-based magazine "54 Etats".

The station manager is responsible for training programme producers in compliance procedures, including procedures for live programming as well as for pre-recorded programming. Training is normally on a one-to-one basis as part of the induction process prior to going on air or producing pre-recorded programmes for broadcast. Training is adapted to context to ensure producers are also aware of key issues relating to their editorial content, for example emphasis may be different for a music show compared to a magazine programme. Refresher workshops are offered from time to time to ensure producers are up to date with and maintain awareness of compliance issues.

Compliance training will be mandatory for all staff and volunteers that have production responsibilities.

All programme producers will be trained in compliance procedures, including procedures for live programming as well as for pre-recorded programming. This will include ensuring awareness of the Ofcom Broadcasting Code and where to access it when necessary.

For the majority of live programmes the producer is also the main presenter and is responsible for ensuring compliance while on air. This includes identifying potential risks, preparing guests in advance, ensuring compliance while on air and taking swift remedial action where necessary, for example making an on air apology, or correcting misinformation. Where a potential breach occurs they are required to report this to the station manager together with information on their response to the matter.

An incident log will be kept of any potential breaches and the response to them.
