The BBC should either remain as open as is possible (without allying themselves to commercial forces) or it should have its whole public service license revoked and compete as a 100% commercial company without a licence fee from the public.

The question is - does the BBC wish to be a public service broadcaster and take its income from a compulsory public licence fee or does it wish to be a commercial operation and take its income from the usual commercial sources.

The BBC should lose the right to the first option as soon as it starts deliberately limiting access to its broadcast material for commercial interests.
