Application for a Grant or Variation of Recognised Spectrum Access for a Receive Only Earth Station

This form should be used to apply for a new Grant of Recognised Spectrum Access (RSA) for a Receive Only Earth Station (ROES) or to apply to vary an existing RSA Grant in the bands 1690 – 1710 MHz, 3600 – 4200 MHz, 7750 – 7900 MHz or 25.5 – 26.5 GHz. An RSA Grant is valid for a site and can incorporate any number of receiving earth stations that are located within 500 metres of a nominated site centre.

The technical parameters of each RSA for ROES 'deployment' must be provided by the applicant in a separate spreadsheet, which you can obtain by emailing spectrum.licensing@ofcom.org.uk. An earth station 'deployment' is a unique 'path' between an earth station and a satellite. A separate spreadsheet is required to define each earth station deployment.

If you wish to modify the technical parameters of an existing earth station deployment on a Grant, please request a copy of the spreadsheet containing the parameters of the existing deployment. Please note that the technical information you provide will be used in the coordination procedure with other users of the radio spectrum.

Please ensure this application form is signed and dated at the bottom and use capitals throughout. Please also keep a copy of the completed application form.

Guidance Notes for completing this Application

These notes and application form relate to the issue of a Grant of RSA for ROES under the Wireless Telegraphy Act 2006.

In the case of a private firm which is not a Limited Company, the full name of each partner or sole trader should be given. Limited liability partnerships (LLPs) are to be regarded as a form of limited liability company. Grants can only be granted

to applicants for the purposes of conducting a business or of providing a professional or public service. Grants cannot be granted to unincorporated associations.

The processing of the application may be delayed if any of the details given on this form are not complete or correct.

1 Applicant details	
RSA Grant number	If the application is for a variation to an existing Grant please provide the RSA Grant number, otherwise leave blank.

Specified as Latitude (North/South) and Longitude (East/West) of the Greenwich meridian in degrees, minutes and seconds of arc using the WGS84 datum.
