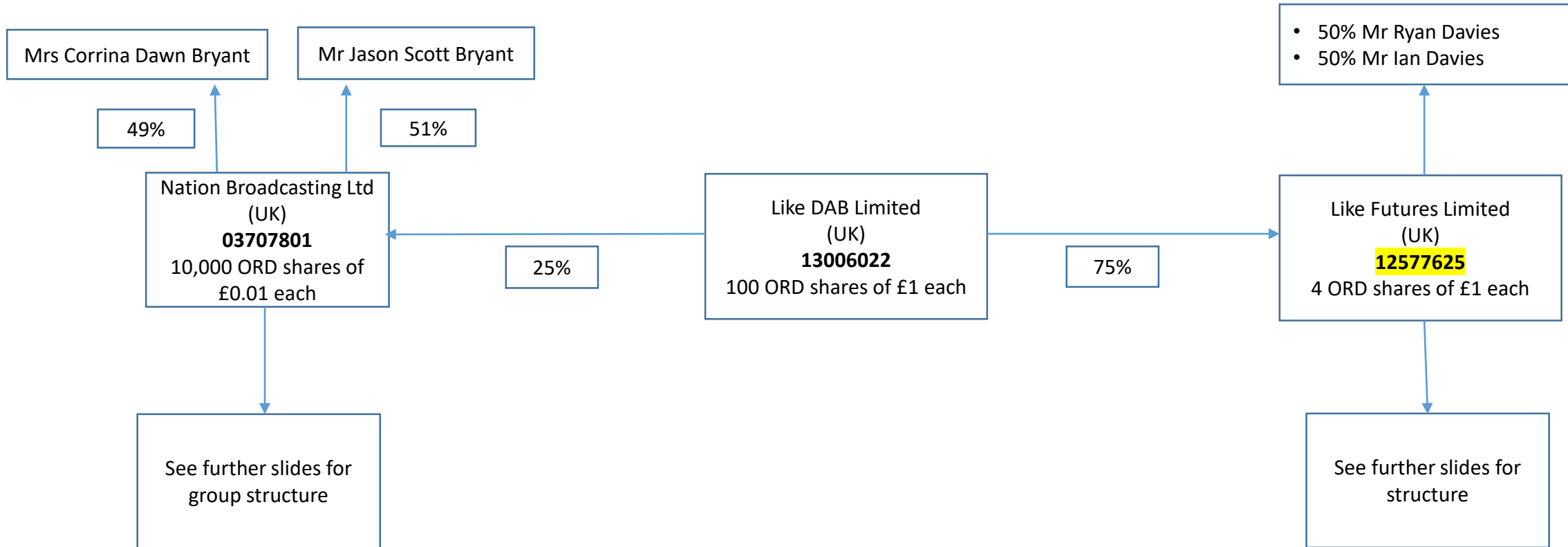
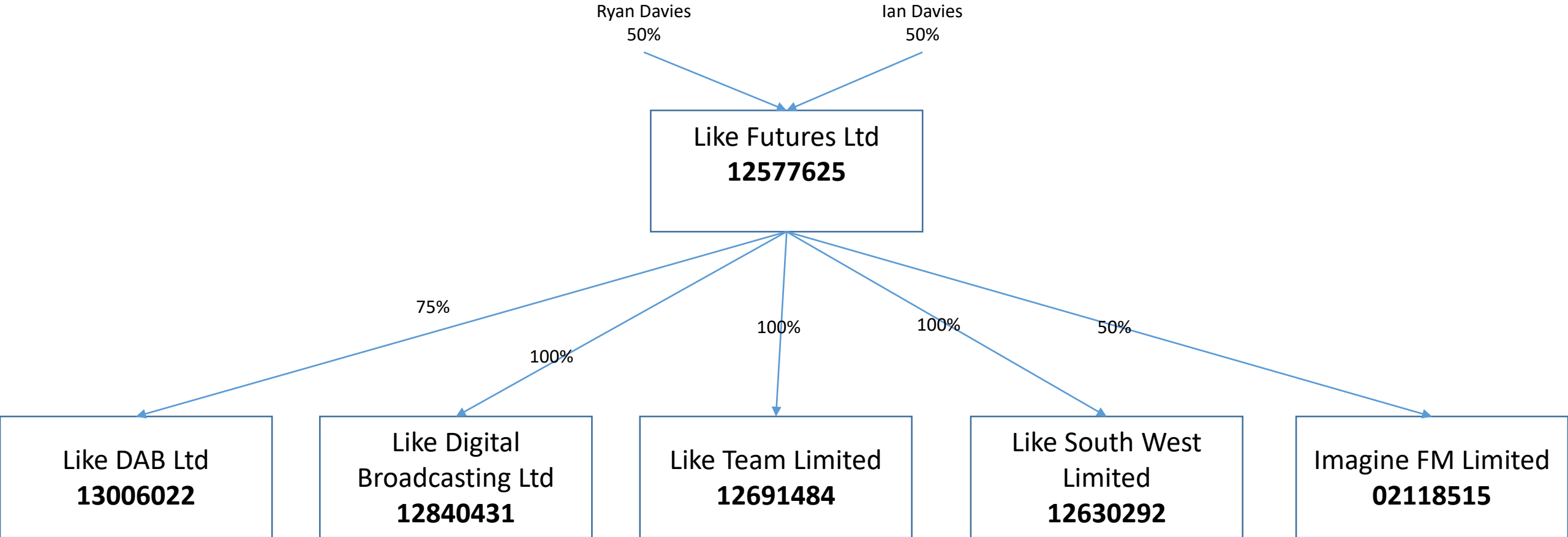


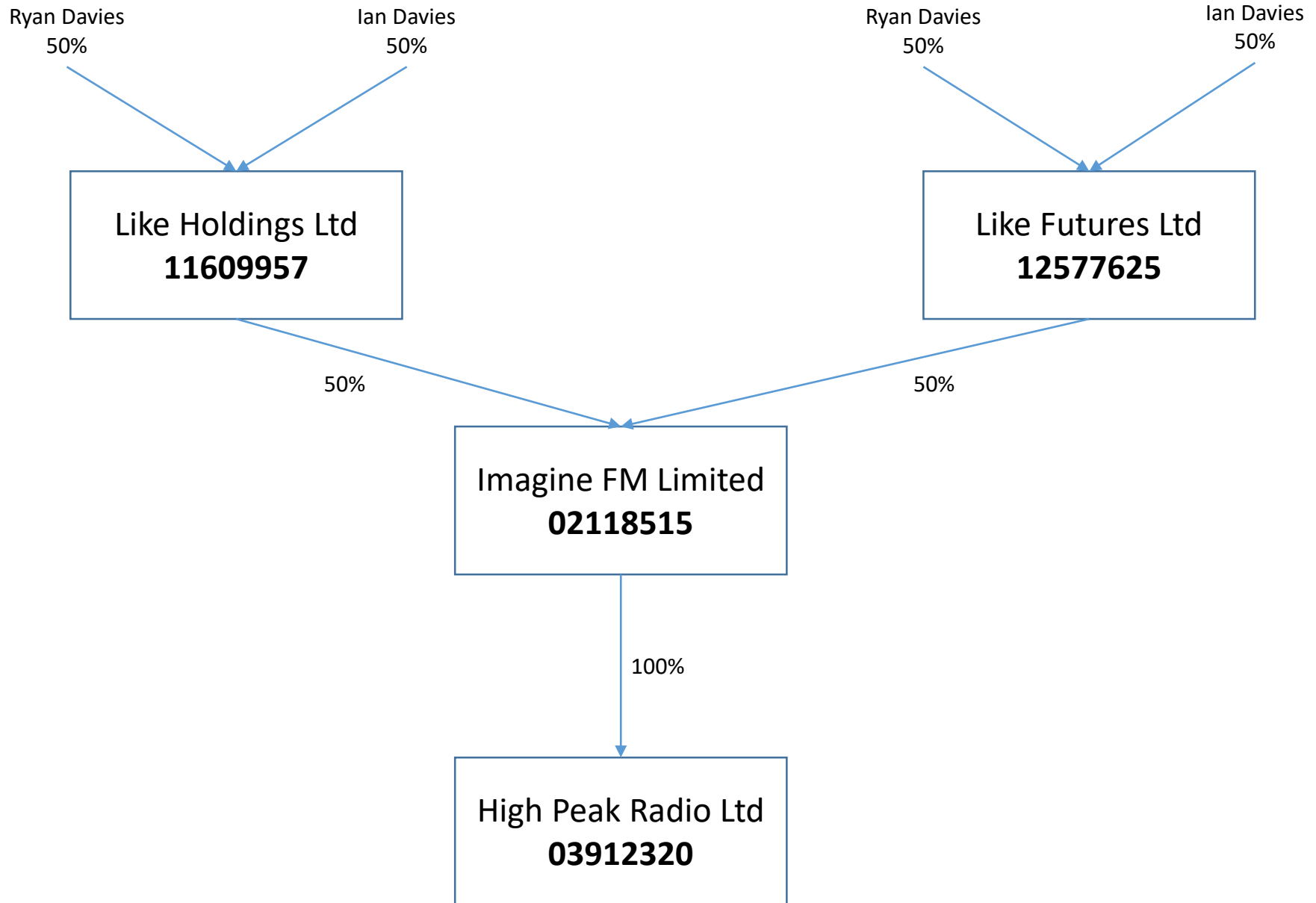
Company Structure – Applicant company – Like DAB Limited - November 2020



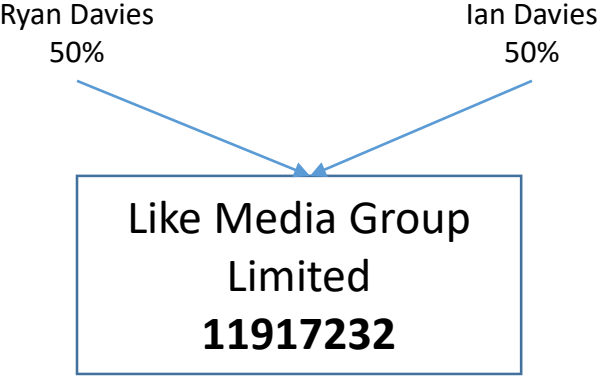
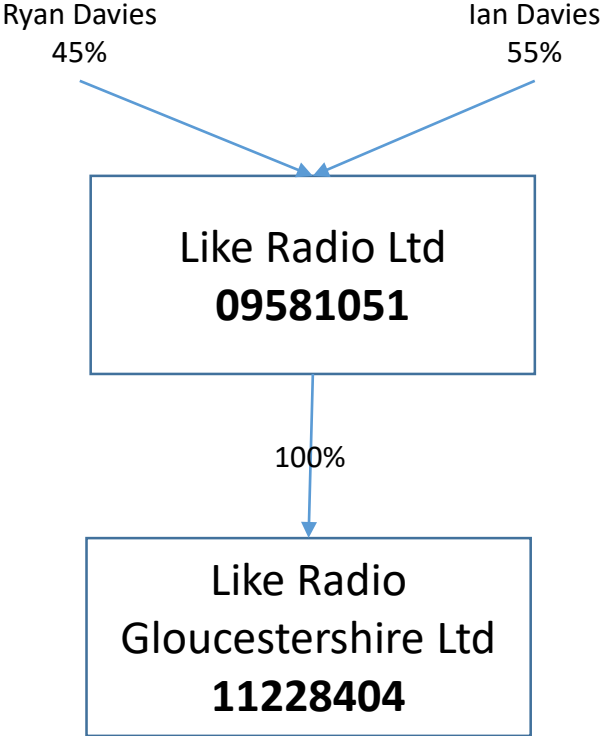
Company Structure – Affiliate company – Like Futures Limited - November 2020



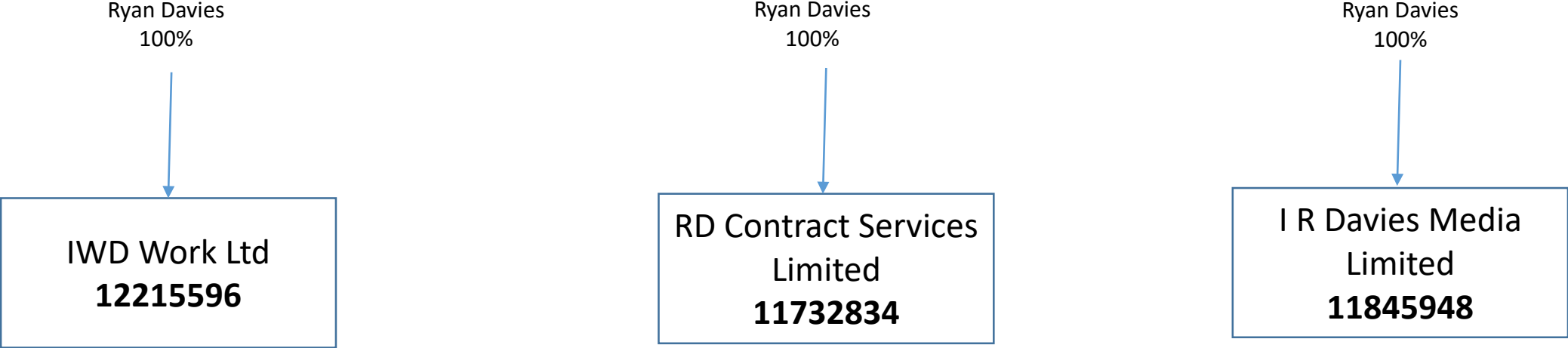
Company Structure – Further associated companies - November 2020

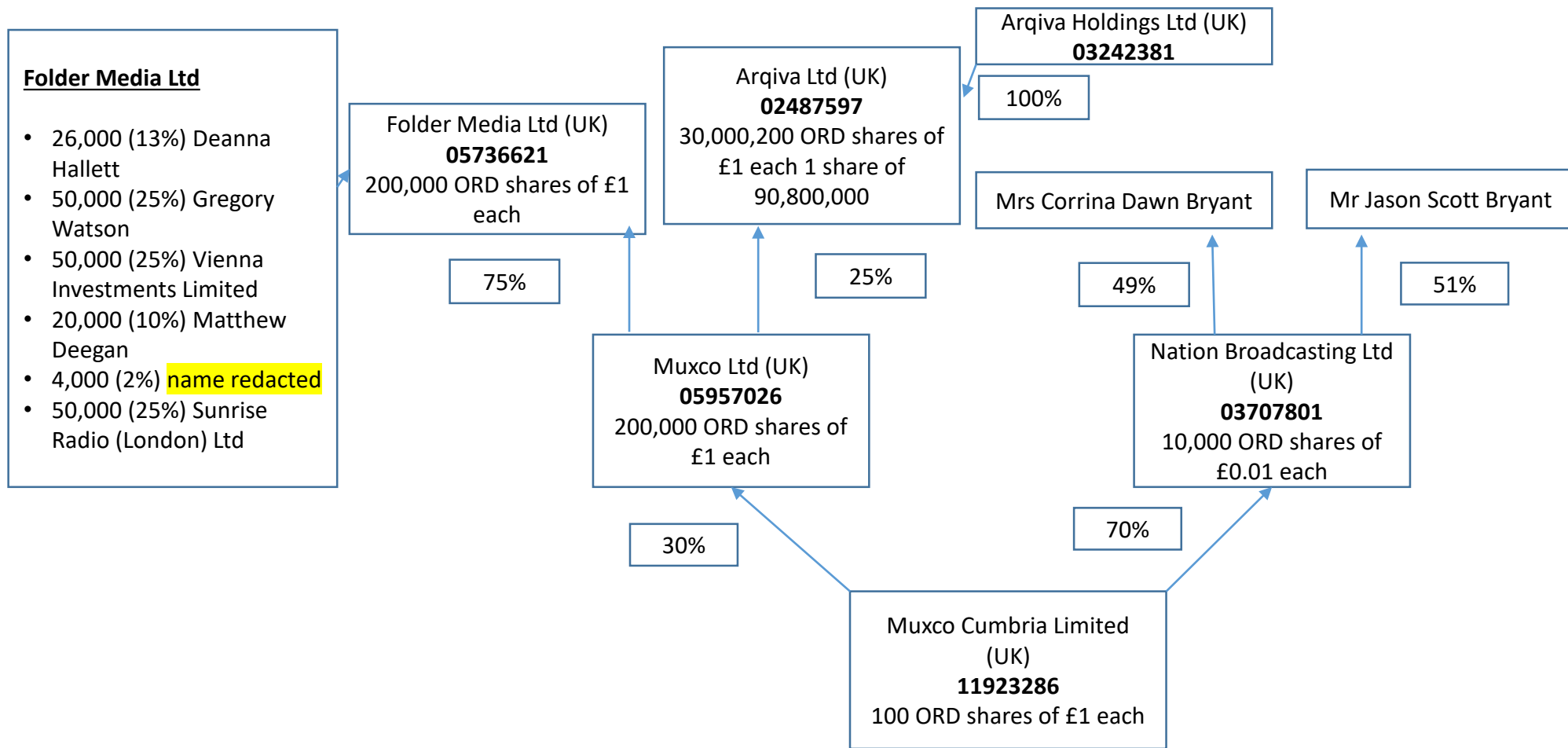

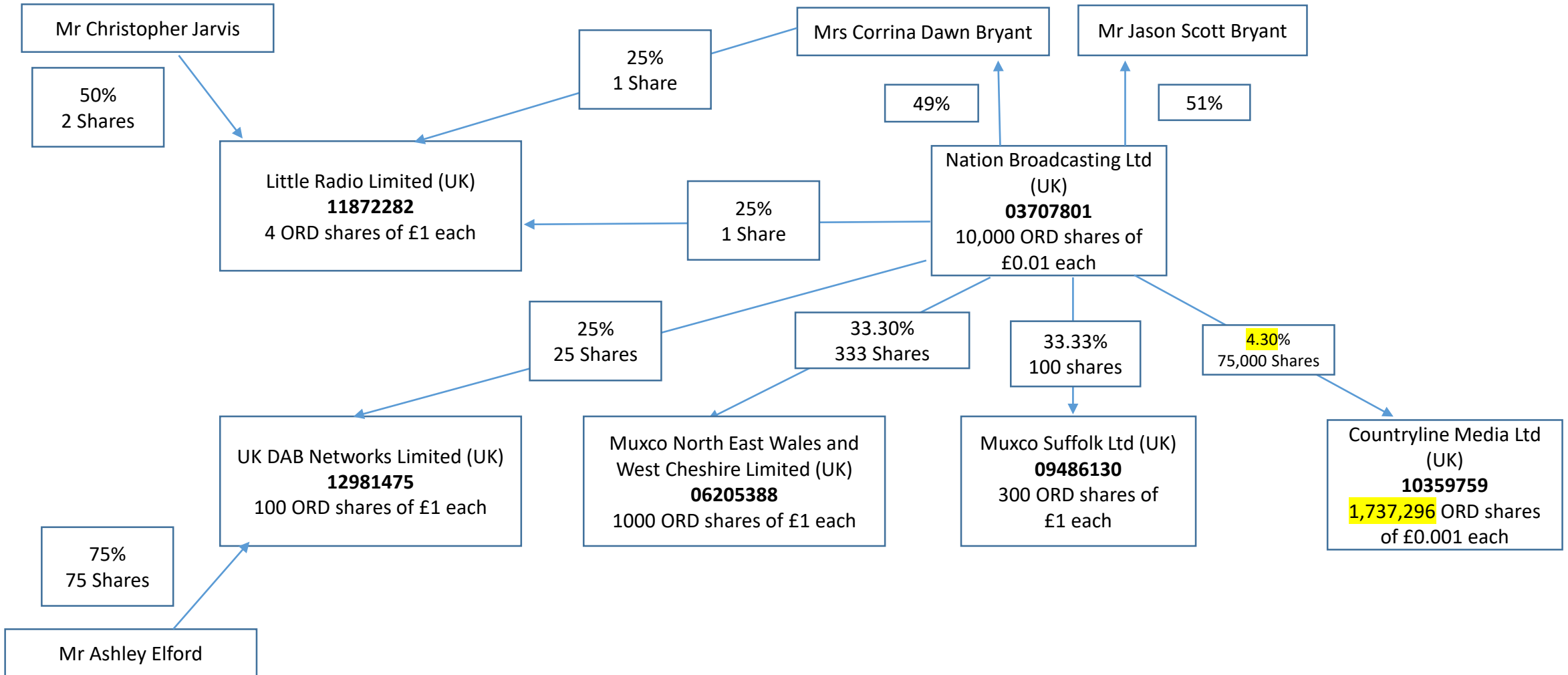

Controlling and Majority interests – Muxcast One Ltd



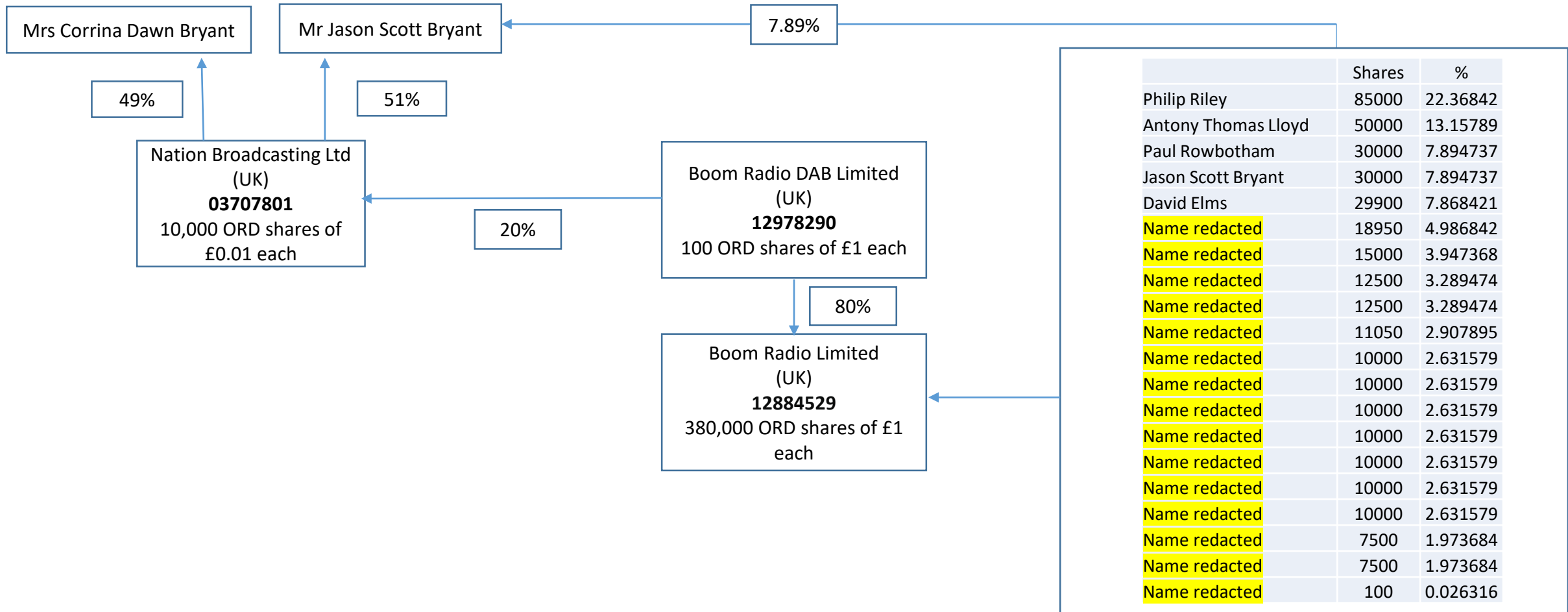
