Technical Report -Adult Users' Attitudes to Age Verification on Adult Sites

Preface

The Adult Users' Attitudes to Age Verification (AV) research was undertaken by Yonder Consulting on behalf of Ofcom. The main objectives of this study were to understand adult internet users' past experiences with AV methods online, and their attitudes towards these different methods in general as well as in the specific context of accessing pornographic content online.

The insights drawn from this research will inform relevant aspects of Ofcom's future work on AV under the Video-Sharing Platform (VSP) regime and help to guide Ofcom's engagement with adult VSPs regarding their AV measures. This research will also contribute to Ofcom's understanding of the wider context for AV on adult sites.

The research used a mixed-method approach consisting of a quantitative online survey and qualitative focus groups and in-depth interviews. Further information about the study is summarised in the sections below.

Summary of Approach

- This research was a mixed-method quantitative and qualitative study, conducted with a sample of UK adults aged 18+, to understand adult internet users' attitudes to AV on adult sites.
- Respondents for the quantitative phase of the research were recruited via Yonder's proprietary
 online panel 'YonderLive', which contains around 150,000 panellists from the UK. The gender
 breakdown of the sample was skewed towards men to reflect the main profile of X-rated adult
 site/app users. This targeted approach allowed us to better understand the attitudes towards
 AV by users of these sites.
- A total of 2,158 quantitative interviews were conducted between 22nd March to 10th April 2022.
- The qualitative phase of this research followed on from the quantitative element. For this stage, 4 x 90-minute in person focus groups were held in London and Manchester alongside 12 x 45-minute individual interviews, which were held online with participants recruited from across the UK.
- Qualitative research participants were recruited via a recontact sample from the AV quantitative survey, complemented with 'free-finding' methods. Individuals were selected based on their age, gender and self-reporting of having seen or not seen online pornographic content at any point in the past.

Quantitative Research

Introduction

Yonder Consulting surveyed 2,158 UK adults aged 18+ to understand adult internet users' past experiences with AV methods online and their attitudes towards these different methods, both in general and in the specific context of accessing pornographic content online.

Details of the sample design, research methodology, and weighting procedures for this study are outlined on the following pages. A note on statistical reliability is also included.

Sample Design

A sample of UK internet users aged 18-84 was provided by Yonder's proprietary online panel, <u>YonderLive</u>, which is made up of 150,000 internet users across the UK.

Quotas

Interview quotas were applied so that the final sample was skewed towards men to reflect the main profile of X-rated adult site/app users. These quotas were sourced from data which established the real user profiles of adult sites.

Quotas were set on the following variables:

- Gender
- Age (18-24, 25-34, 35-44, 45-54, 55-64, 64-74, 75-84)

Fieldwork

All interviews were conducted between 22nd March to 10th April 2022 using Yonder's online panel (YonderLive), closing fieldwork at 2,158 interviews.

Due to the highly sensitive nature of some of the research topics, respondents were allowed to opt out of questions relating speficially to experiences of pornographic content online. They were also forewarned of the sensitive nature of the research topic and asked to give their consent to participate,



in line with Market Research Society (MRS) guidelines. A total of 142 respondents opted to end the survey due to the sensitivity of the content.

Duplication checks took place to ensure that respondents could not complete the survey more than once. As well as duplication checks, Yonder carried out the following checks during and post fieldwork as standard:

- IP geo-locator checks to ensure the respondents are all based in the UK.
- Front and back-end quality control questions within the survey to ensure respondents are answering logically and consistently.
- 'Trap' questions within the survey to ensure respondents are paying attention and reading each code i.e. At random, respondents would be asked to select a specific code and those who did not choose the correct option would be removed from the data.
- Manual speeder check post-fieldwork to remove any respondents deemed to have proceeded through the questionnaire at an unreasonable pace.
- Manual flatlining checks post-fieldwork to check grid questions and ensure respondents aren't answering the same codes across an unreasonable range of grid / scale questions.
- Open end checks to ensure respondents are answering thoughtfully and not spamming answers.

Weighting

The data has not been weighted as the sample naturally fell in line with the demographic profile of X-rated adult site/app users, particularly the skew towards men.

Significance Testing

Significance testing for the Adult Users' Attitudes to AV on Adult Sites research has consistently been applied at 95%.

The following was applied to published data tables:

- If unweighted bases are less than 10 for any total columns or cross-breaks for any of the tables, these have been removed.
- Added a note on the tables to explain that where data is not shown, this is because the base sizes were too small to allow reliable interpretation of the data.
- We include the following note to tables where relevant: "Data suppressed where unweighted base is lower than 10. ** very small base (under 30) ineligible for sig testing, * small base (under 50)".

Guide to Statistical Reliability

The variation between the sample results and the "true" values (the findings that would have been obtained if everyone had been interviewed) can be predicted from the sample sizes on which the results are based, and on the number of times that a particular answer is given. The confidence with which we can make this prediction is calculated at the 95% that is, the chances are 95 in 100 that the "true" values will fall within a specified range. This sample was unweighted so does not require the use of an Effective Sample Size.

The table below illustrates the required ranges for different sample sizes and percentage results at the '95% confidence interval'.

For example, if 30% or 70% of a sample of 2,158 gives a particular answer, the chances are 95 in 100 that the "true" value will fall within the range of +/- 1.9 percentage points from the sample results.

When results are compared between separate groups within a sample, different results may be obtained. The difference may be 'real', or it may occur by chance (because not everyone has been interviewed). To test if the difference is a real one – i.e. if it is 'statistically significant' – we again have to know the size of the samples, the percentages giving at a certain answer and the degree of confidence chosen. If we assume 95% confidence interval, the difference between two sample results must be greater than the values given in the table below to be significant.¹

Qualitative Research

Introduction

Yonder conducted a combination of focus groups and in-depth interviews to explore attitudes to AV within the context of accessing pornography.

Four in-person 90-minute focus groups were held in London and Manchester with 6 participants within each session. 12 x 45-minute online in-depth interviews with participants recruited from across the UK were also conducted online via Zoom.

The focus group participants were recruited to explore differences in age and gender amongst individuals who self-identified as having accessed pornography.

The depth interviews were recruited both to explore differences in age and gender amongst individuals who self-identified as having accessed pornography and also the attitudes of individuals who were both supportive and less supportive of AV. To determine attitudes towards AV, participants were asked whether they agreed or disagreed with a series of statements as part of the screening process.

Fieldwork was conducted between 22nd July and 16th August 2022.

Recruitment

Respondents were recruited through re-contacting survey respondents and free-find techniques.

At the end of the quantitative survey, respondents were asked whether they were interested in participating in a follow-up qualitative study. Details of consenting respondents were collected, and if they fitted certain criteria, they were invited to participate in the depth interviews. This data was managed and stored in line with GDPR commitments.

Free-find recruitment involved specialist qualitative recruiters using online, telephone and in-person methods to find participants that did not belong to a specific panel.

Participants were incentivised for their time and to thank you them for taking part in the study. Focus group participants were incentivised with £60 and depth interview participants £45.
