### 1. Overview

### The purpose of this form

- 1.1 You should complete this form if you are applying for a Community Digital Sound Programme (C-DSP) licence.
- 1.2 A digital sound programme service intended for broadcast by means of a local or small-scale radio multiplex service requires either a C-DSP licence or a local DSP licence. Ofcom's published guidance notes set out some of the key issues that potential applicants need to consider in deciding which type of licence is suitable for them. In summary, C-DSP services are not run for financial gain and are required to provide social gain. C-DSP licences therefore include strict conditions to ensure that happens, and provide less flexibility than a local DSP licence. However, they do provide access to capacity that small-scale radio multiplex service providers are required to reserve solely for C-DSP services.
- 1.3 A C-DSP licence will be required even if the same programme service is also provided on any other platforms (e.g. FM, satellite), as separate licences are required for those.
- 1.4 As noted above, small-scale radio multiplex services will have reserved capacity for C-DSP services. Issue of a C-DSP licence does not, however, guarantee carriage on a small-scale (or local) radio multiplex service. That is a matter for agreement between the C-DSP licensee and the multiplex service provider, and there may be more C-DSP licences issued in a locality than there are reserved slots on the small-scale radio multiplex service. Note that a C-DSP service does not necessarily have to broadcast using reserved capacity. It can use unreserved capacity on a small-scale radio multiplex service or capacity on a local radio multiplex service, again subject to agreement with the multiplex service provider.
- 1.5 An application for a C-DSP licence will be accepted only once Ofcom has advertised the licence for the small-scale radio multiplex service upon which the proposed C-DSP service is intended to be provided. There is no closing-date by which an application for a C-DSP licence must be submitted (i.e. it can be submitted at any time after the licence for the relevant small-scale radio multiplex licence has been advertised).

- 1.7 Ofcom requires complete and accurate information to assess applications. Radio Faza 97.1FM is aimed at the South Asian, British Asians and Eastern European communities of Nottingham. Most of these people have links through their family with their home land or land of origin. Over the course of each week, programming is broadcast in a multilingual format, which includes Urdu, Hindi, Punjabi, Pashto, Pathwari, Bengali, Eastern European languages and English. The service provides original output for a minimum of six hours per day during week days.

The studio is located within the licensed coverage area situated in 116B, Leslie Road, Nottingham, NG7 6PR which is the most populated area of Nottingham with members of the South Asian and Eastern European Communities.

Radio Faza 97.1FM offers free media training, a platform for the target community to air its views and concerns, and acts as a springboard for local talent. It promotes health, education, training and employment opportunities to empower members of the community, including young people and women.

3.6 How will you ensure that your proposed C-DSP service is run on a not-for-profit basis? Radio Faza 97.1FM (Radio Fiza Ltd) is a registered Limited Company by Guarantee since 2003. It is a not-for-profit organisation running since 2001 as part of the Radio Authority pilot trial before being awarded a community radio licence as part of the community radio order in 2004 in 2005 and has been on air to present day on FM with charitable aims and objectives. Any profits gained are reinvested into the company to deliver its aims and objectives. At best Radio Faza's DSP service will be cost-neutral, but we are budgeting to subsidise it from existing surpluses achieved by the established FM service.

### Social gain

Radio Faza 97.1FM has over the past 13 years informed, educated, inspired and entertained the local community. We have worked with many Community groups to promote their service benefitting the local community. Also, have worked with the NHS to promote their health and wellbeing campaigns, majorly cancer campaigns, vaccine campaigns, covering Covid-19, translating vital messages in multiple community languages and more; Nottinghamshire Police to promote their recruitment drive, antisocial behaviour, drugs and crime; Nottinghamshire Fire and Rescue to promote awareness campaigns and recruitment drive; English Cricket Board for promoting women's cricket and more; Royal Air Force to promote their recruitment drive; Department of Education to promote their covid campaigns and many other similar organisations. Our local authorities Nottingham City Council and Nottinghamshire County Council use our platform to reach the South Asian and Eastern European communities of Nottingham and the shire to give out messages, promote their campaigns. We have been very successful in training young people and women in radio training. We are happy to say that many of our volunteers who started their working career/work experience with us progressed into full-time employment with the confidence they gained from radio experience; some even got better opportunities in media.

The service promotes cultural values and identity, providing advice and support to the community in a multilingual environment. The service broadcasts:

- Music The main types of music broadcast over the course of each week are: all genres of South Asian and English music with the majority from the Indian sub-continent and including Bollywood, Lollywood and Bhangra.
- Speech The main types of speech output broadcast over the course of each week are: daily community morning show, drivetime show, community features, interviews, discussions and more.
- The service provides a range of community benefits (social gain objectives mandated by statute) for the target community, both on-air and off-air, and in doing so, achieves the following objectives:
- the facilitation of discussion and the expression of opinion,
- the provision (whether by means of programmes included in the service or otherwise) of education or training to individuals not employed by the person providing the service, and
- the better understanding of the particular community and the strengthening of links within it

Members of the target community contribute to the operation and management of the service. The service has mechanisms in place to ensure it is accountable to its target community.

Radio Faza 97.1FM has always maintained an open-door policy, allowing individuals in the community to engage with the station on different levels of programming, broadcasting and administration. Members of the target community contribute to the operation and management of the service. We engage with the community we serve through face to face meetings, regular events, allowing visits to the studios, over telephone, messages, emails, social media and on numerous programmes throughout the week in a diverse range of topics. We hold regular on-air discussions on local and national issues which interest or concern our local community. In line with our laid aims and objectives, we provided a range of community benefits for the target community, both on-air and off-air, and in doing so achieve the following objectives:

- the facilitation of discussion and the expression of opinion,
- the provision (whether by means of programmes included in the service or otherwise) of education or training to individuals not employed by the person providing the service, and;
- a better understanding of the particular community and the strengthening of links within it.

The service has mechanisms in place to ensure it is accountable to its target community.

3.9 How will you ensure that members of your target community(ies) can gain access to the facilities used to provide your service, and receive training in using these? In particular, please set out how this will be done practically, formally and/or informally. **Answer in fewer than 400 words**.

As explained earlier, Radio Faza 97.1FM has always maintained an open-door policy. We offer training to individuals within our target community who express a desire and willingness to take part and would like to become presenters. This training is ongoing to both new and current presenters/volunteers and we link in with multiple agencies including two renowned universities of Nottingham, third sector organisations and social and community groups. Community members are also encouraged to email us with their interest. Everyone is required to fill in a volunteer agreement form. Apart from formal training, we have senior presenters who mentor new recruits and help maintain utmost quality production. Our audience are encouraged to contact us through various methods, such a phone, website, email, social media, or in person.

3.10 How will your service provide better understanding of your target community and the strengthening of links within it? **Answer in fewer than 200 words**.

For 23 years, Radio Faza 97.1FM has played a vital role in shaping lives through diverse programs covering society, health, education, finance, sports, and global news. Broadcasting in English as well as popular South Asian and Eastern European languages, we connect deeply with our community. By using a mix of local vernacular and community languages, we bridge gaps and discuss local issues, promoting opportunities and inclusivity for those with limited English proficiency. Our partnerships with local agencies and organizations enable us to reach difficult-to-access service objectives. Regular feedbacks and consultation opportunities during organised community meetings/events helps us with better understanding of our target communities. Working with local groups, we foster positivity and unity and strengthen the links within the community by providing discussion shows on local needs and wants, airing people's views and concerns, and promoting local opportunities such as employment, training opportunities and more.

Radio Faza 97.1FM has been involved in community radio broadcasting for over 20 plus years. In all these years, it has demonstrated its commitment and its longevity to serve the community, it targets which includes working with statutory and community groups, delivering services that are relevant and beneficial to the local community including training people from grass roots level to producing and presenting their own shows, especially women and young people. We have worked with NHS, Police, Nottingham City Council with various campaigns that help improve our local area and are beneficial to the local community.

Radio Faza 97.1FM also understands the need to evolve itself with the changing dynamics of its target community through ongoing dialogue and always being able to offer access, training and a platform to raise individuals expectations.

Radio Faza 97.1FM has demonstrated its relationships with multiple agencies including its partners in

third sector and allowing those organisations to reach a target community where they find it hard to reach and bridge the gap.

### **Participation**

Radio Faza 97.1FM, as per its Key Commitments, has always ensured and will continue to ensure that its target community has opportunities to participate in the operation and management of the service through regular meetings and discussions over the year; they have the opportunity to provide valuable insights, feedback, and suggestions, directly influencing the station's trajectory through open communication channels.

- To empower community members with the necessary skills for active participation, we initiate training programs. These sessions focus on essential areas such as radio production, hosting/presentation, technical support and others.
- We accommodate young people with work experiences which often brings back their contributions in manifold ways.
- Active encouragement for community members to volunteer at Radio Faza forms an integral part of our strategy. Volunteering offers hands-on involvement and instils a sense of ownership. From contributing to programming to engaging in technical operations, volunteers play a crucial role in enhancing the community's connection with the station. This approach not only fosters community engagement but also provides individuals with valuable experience in the media industry.
- Building partnerships with local community organizations serves to strengthen our outreach efforts. Collaborative projects, events, and initiatives with these organizations provide opportunities for community members to actively participate in the station's activities. - Hosting regular community engagement events, forums, and feedback sessions is fundamental for maintaining an ongoing dialogue. Zakir Ahmed has the experience in community broadcasting, teaching Radio Broadcasting and maintaining overall compliance of the service and delivery since 2017. He has handled two complaint related investigations from Ofcom between 2017 till date – both complaints were dropped on submission of evidences as compliance was being strictly followed.

As the head of operations auditing committee, it is the duty of the Station Manager to ensure that all staff is adhering to Ofcom's regulations. The compliance committee will make sure every member of staff is aware of and has signed a compliance agreement before any work is assigned. The Director of Radio Faza oversees and provides input on all compliance procedures. A Broadcasting Guide (Radio Faza's Handbook) is provided to all presenters. After going over every written material, they have a chance to talk and pose questions.

Radio Faza runs regular training for all staff and volunteers and presenters on a regular basis over the year. We have a dedicated core team which are now settled into the role of a presenter and understand compliance and broadcasting rules.

Radio Faza has been on air since 2002 as per Community Radio Licence and as such has made sure its policies, its training, its availability of the Broadcasting Code is regularly used for reference.

Radio Faza uses ZARA Studio as a playout system to ensure all material is radio friendly.

Radio Faza has a Sonifex Mixer and a dedicated PC to retain all recordings as per licence requirement. An additional back up is also in place in a separate hard drive to fall back in case of hardware failure.

We have a pool of mature volunteers/presenters who have been with us over a long period of time and understand the need to check any material to be aired is suitable and observes Ofcom's Broadcasting Code.

Our Station Manager ensures live content that is being aired is suitable, is trained to cancel or abort any broadcast deem unsuitable.

We have a written agreement where all our staff and volunteers must sign which states material to be aired should be checked beforehand, and the penalties non-compliance carries.

The system and procedure we have in place in order to observe Ofcom's Broadcasting Code are to ensure all pre-recorded content is checked to ensure it suitability for broadcast.

Radio Faza has weekly checks to ensure we are delivering on our key commitments which are a core function of the Studio Manager. A regular review of delivery of service is always observed and monitored.

A soft copy detailing the presenter; his/her guests and content is always updated, soon after the show is conducted.

Every activity is monitored and guided by experienced volunteers and overseen by Zakir Ahmed, the director of the radio himself. These activities are pre designed and volunteers conducting the events/workshops/trainings are also briefed and the compliance requirements revisited and reminded.

Pashto – We have 1 compliance team member who is fluent in this language (mother tongue) and will be responsible for ensuring the content complies with Ofcom's code and rules

Pathwari - We have 2 compliance team members who are fluent in this language and will be responsible for ensuring the content complies with Ofcom's code and rules

Bengali - We have 1 compliance team member who is fluent in this language (mother tongue) and will be responsible for ensuring the content complies with Ofcom's code and rules.
