

Satellite (non-geostationary earth station) radio licence application form – OfW564

Who should use this form?

You may use this form to apply for, amend or surrender a satellite (non-geostationary earth station) licence in the United Kingdom.

This "site" licence can incorporate any number of earth stations that are located within 500 metres of a nominated site centre. The technical parameters of each earth station 'deployment' must be provided by the applicant in a separate spreadsheet, which you can download from Ofcom's website.

For licensing purposes, an earth station 'deployment' is a unique 'path' between an earth station and satellite. A separate spreadsheet is required to define each earth station deployment. If you wish to modify the technical parameters of an existing earth station deployment on your licence, the parameters you specify in the spreadsheet will completely overwrite the parameters for the existing deployment. You may ask Ofcom for a copy of the spreadsheet containing the parameters of the existing deployment. Also note that the technical information you provide will be used in the coordination procedure with other users of the radio spectrum.

Conditions

Under the Wireless Telegraphy Act 2006, you must have a licence issued by Ofcom before you establish or use any earth station radio equipment unless it is authorised by a specific exemption.

Communication preference

Where possible, all correspondence will be sent to licensees electronically.

If you do not wish to receive documents electronically, you must opt out by ticking the box against each contact to receive correspondence by post.

Completing this form

Before completing this application form, you are advised to read the <u>additional guidance</u>. Ofcom intends to publish applications for this licence to allow other parties to provide information regarding interference or the competitive impact. Before publishing, Ofcom will redact the personal information contained in this form. You also have the option to provide confidential information in answer to questions D.1, D.2 and D.4.

When completing this application please refer to the notes and complete in dark ink in BLOCK CAPITALS.

All fields are mandatory unless stated otherwise.

Payment

Payments should not be included with this application. Ofcom will invoice later. Payments must include all bank charges. If Ofcom does not receive full payment, it will return any partial payments received.

Radio licence fees

The licence fee should only be paid to Ofcom after you have been invoiced. The licensee must pay the relevant fee as provided for by section 12 of the WT Act and the Regulations that have been made under that section. If you fail to pay the licence fee, Ofcom may revoke the licence

The remainder of these guidance notes provide advice on specific questions.

SECTION B – Customer details

Question B1a - Existing customers

If you already hold an Ofcom radio licence, you should write your customer reference number in the box provided. Your customer reference number will be quoted in licence documentation or correspondence that we have previously sent to you.

Question B1b - Harmonising a licence

Ofcom can align invoices for similar licence products to one consolidated date. This makes invoicing and payments easier to manage.

The conditions for harmonising a licence are:

- The licence must be under an existing customer reference number;
- Must be the same licence product;
- Must have identical payment terms (e.g. every 5 years);
- Must have an identical payment contact; and
- Must be no outstanding invoice against the licence.

Question B2 - New customers

A licence can only be issued to a legal entity. You should complete the appropriate option provided or if these are not appropriate then provide your details under other legal entities. For a partnership, please give the full name of one partner and supply a list of all other partners. The main partner is also required to sign the declaration in Section E.

Question B3 - Licensee address

If you are applying on behalf of a Limited Company, a Public Limited Company or a Registered Charity, the registered address of the organisation must be used. The licensee will receive all licensing documentation and correspondence.

Question B4 – Licence contact name and address

This can be an additional contact who should also receive licensing documentation and correspondence.

Question B5 – Payment and billing contact

The payment (billing) contact can be different to either the licensee or licence contact.

Question B6 – Third-party contact

If the licence is being handled by a third-party contact such as a radio supplier, technical contact or consultant, then this can be provided.

Provide a name for the site centre.

Question C2 – Site address

Provide the address of the site.

Question C3 – Location of site centre

Provide the location of the nominated site centre to 1 metre accuracy. When submitting NGR please provide in the following format: National Grid Reference – NGR (e.g. TQ 32284 80497). When submitting latitude and longitude values please provide in decimal degrees format: Latitude/Longitude (WGS84) (e.g. 52.421685, 1.500430). The values for latitude and longitude are bounded by ±90° and ±180° respectively.

SECTION D - Additional information

Except for question D.4, all questions are mandatary. Further help and guidance in answering these questions can be found here.

We will accept the information you provide for questions D.1, D.2 and D.4 in all types of commonly used formats. If you wish to use other formats, for example technical models or specialised software files, please check with Ofcom first.

If you wish parts of the information you provide for questions D.1, D.2 and D.4 to be kept confidential, please submit two separate annexes: a confidential annex containing all the information; and a separate non-confidential annex containing the information that Ofcom can publish with your application.




