Question 1: Do you agree that copy management would broaden the range of HD content available on DTT and help secure its long term viability as a platform? :

No.

They are *capable* of making all HD content available now, they simply choose not to as it will either cost too much to purchase the rights necessary or down to stubbornness of the part of content providers.

They are under the mistaken impression that DRM is infallible and a magic-bullet to prevent material appearing on the internet.

If implemented, it is simply a matter of time until the encryption method is broken by third parties, and all of this will have been for nothing.

Anything that can be viewed, can be copied, and no amount of encryption will prevent this.

Question 2: Do you agree that the BBC?s proposed multiplex licence amendment represents the most appropriate means for securing an effective content management system on HD DTT? :

No, it is an 'ugly hack' to bolt unnecessary functionality onto freeview that it was not designed to handle.

No, Since the content management technology is likely to be implemented in software, hardware costs should be kept to a minimum - however any costs with licensing of encryption technologies and any upgrades required to make HD DTT receivers capable of decryption in realtime will be unavoidably applied. As far as interoperability is concerned, any incompatible device will have to be replaced - and this is a significant cost.

Question 7: Do stakeholders agree that the BBC?s proposed Huffman Code licensing arrangements would have a negligible effect on the market for HD DTT receivers? :

Yes, every manufacturer will simply have to license and implement the appropriate encryption scheme. So long as licenses are available on a non-discriminatory basis at equal cost then this should have no effect on the market.
