Every one of them uses an 070 phone number and every one of them is run by fraudsters, operating outside the UK, targeting people planning to visit the UK for a holiday. All of the content of the websites have either been copied from London estate agents websites or other legitimate holiday flat rental websites. The first one features my own holiday apartment which I let out. I can't do anything to get my photos and my description off this site, but people are trying to book holidays in it with the fraudster who offers my flat at half price and disappears with the money. It reflects very poorly on London and the UK. Yes the fraudster probably isn't based here, but the tourists who are losing their money don't always know that and it reinforces any impression of London as a big bad dangerous place which is not good for tourism. www.thekingsapartment.com (note how Tower Bridge is labelled as London Bridge) Now just Google thekingsapartment and see how many ads this man has put up on free to advertise websites such as Craig's List (all over the world from Sydney to Berlin), Gumtree, Londonrent.org, Yakaz.co.uk and Rentals-London.com (this might even be another fraudulent site).

The holiday apartment scams aren't monitored by PhonePayPlus and because they take place outside the UK the London Met Police are powerless to do anything about them. But they reflect very badly on UK plc and on all the internet forums where those who have lost money to these con men write and deplore these frauds, they all ask the same question 'what is the UK doing about this?'. And sadly, the answer is nothing.

PNS providers must responsibility for the numbers they give out. It is the same principle as the scams monitored by PhonePayPlus, just a different scam that doesn't

often affect British citizens, but as it affects our tourism industry, it will come to affect all British tax payers.
