Freedom of Information request: Right to know request

Thank you for your request for information about Ofcom findings and GB News. Your request was received on 26 September 2023 and we have considered it under the Freedom of Information Act 2000.

Your requests and our response

We have provided responses based on the period up to the date of your request.

1 - Does OFCOM have the authority to apply sanctions against broadcast companies/organisations it finds have breached the rules. We believe you do having read <u>Ofcom finds RT in breach of due</u> <u>impartiality rules - Ofcom</u>

Yes, Ofcom does have the power to impose sanctions for breaches of a relevant requirement.

If the answer to that question is positive OFCOM has the authority could you please provide the responses we can attribute as "received from OFCOM" / "an OFCOM spokesperson" to the following questions:

2 – What are the broad range of sanctions OFCOM has at its disposal for broadcast organisations/companies?

Please see our sanctions procedures <u>here</u>, which set out the sanctions available to Ofcom (see paragraph 1.14) and the process we will follow when considering the imposition of a sanction.

3 - Can you provide a list of all complaints about impartiality upheld by OFCOM over the last 5 years ? (If this could be an excel which includes links to the relevant findings and highlight those which concluded sanctions either were being considered or had been applied.)

Between 27 September 2018 and 26 September 2023, Ofcom recorded the following breaches of the due impartiality requirements contained in Section Five of the Ofcom Broadcasting Code ("the Code").

4 - Our cursory review of the Ofcom web site using the search facility suggests that OFCOM can suspend or impose fines - given the seniority of the interviewers (sitting Members of Parliament of the same political party as the Chancellor of the Exchequer), the nature of the bias - it related to fiscal policies and budgets, what level of authority within OFCOM made the decision not to sanction and why was GB News not sanctioned in this fashion?

Please refer to our sanctions procedures, as referred to in our response to Q2.

5 – How many complaints does OFCOM currently have against MPs and/or GB News related to alleged breaches of ""No politician may be used as a newsreader, interviewer or reporter in any news programmes unless, exceptionally, it is editorially justified. In that case, the political allegiance of that person must be made clear to the audience."?

Ofcom currently has five open investigations related to Rule 5.3¹ of the Code, decisions on which will be published in the Bulletin in due course. We log complaints on our complaints database by category of the complaint issue (with reference to the rules in the Code). There is no specific category used exclusively for complaints related to politicians as presenters and such complaints are logged under the category "Due impartiality / bias" which would apply to a wide range of issues under Section Five of the Code.

It is therefore not possible to search for a specific number of complaints under the issue of politicians as presenters, however, complaints Ofcom has considered against GB News and not taken

forward to investigation can be accessed via the <u>Bulletin</u>, navigating to 'Complaints assessed, not pursued' and filtering the service name to GB News to focus just on complaints and individual programmes about that service.

6 – How many complaints in total have there been against GB News specifically – this is number of people who have complained as well the number of investigations Ofcom have channelled these complaints into?

Individual complaints received by Ofcom are assigned to cases. A case is opened when Ofcom is assessing a specific programme or issue and may consist of one or more complaints. From the date of GB News' launch on 21 June 2021 to 26 September 2023, the date of your request, Ofcom received 6,389 complaints (1,794 cases) related to GB News, and launched 17 investigations (16 related to GB News and one related to GB News Radio). For context, in the same period Ofcom received 131,898 complaints (21,161 cases) against all broadcasters and launched 133 investigations.

7 – Does OFCOM have an agreed "service level" with the Government in which to arrive at a finding /determination?

Ofcom is independent of Government and our duties are set out in legislation under the Communications Act 2003. Please see our <u>published complaints</u>, <u>investigations</u>, <u>and sanctions</u> <u>procedures</u> for further detail on the procedures we follow when investigating a potential breach of the Code.

8 - Can an organisation found to be in breach appeal and if so how does it do that and have any successfully appealed an adverse decision?

Yes, Ofcom's broadcasting standards decisions are subject to challenge by way of judicial review. No such challenge has been successful.

9 - Are there any circumstances which would require OFCOM to seek approval from a Minister/ Ministry, MP or a committee of sitting MPs for a decision to sanction a license holder /revoke a licence.

No, we would not seek approval from a Minister or MPs to sanction a licence holder/revoke a licence as Ofcom is independent from Government and makes its own decisions regarding sanctions.

Information Requests

If you are unhappy with the response you have received in relation to your request for information and/or consider that your request was refused without a reason valid under the law, you may ask for an internal review. If you ask us for an internal review of our decision, it will be subject to an independent review within Ofcom.

• the original decision is upheld; or

• the original decision is reversed or modified.

Timing

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter**. There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review. If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision.
