Freedom of Information request: Right to know request

Thank you for your request for information asking if EE or MBNL are present on a particular site.

We received this request on 20 March 2025 and we have considered your request under the Freedom of Information Act 2000 and the Environmental Information Regulations 2004.

Your request

We make this Request for information held by you in regard to the Site.

We confirm the co-ordinates of the site are: Grid Reference: TL 35852 15843 X, Y: 535852, 215843 Latitude, Longitude: 51.824695, -0.03017 (decimal) Latitude, Longitude: 51°49'29"N, 000°0T49"W (degrees, minutes, seconds) Please could you confirm whether EE Limited or MBNL (Mobile Broadband Network Limited) are present on the Site.

Our response

Ofcom offers two different types of licence which authorise licensees to deploy fixed links:

- **“block assigned”** licences, which authorise licensees to deploy as many links or base stations as they wish within the specified frequencies, and
- **“point to point”** fixed link licences, which authorise use of an individual fixed link between base stations in specified locations. Information about all of the point to point fixed link licences Ofcom has issued is publicly available on Ofcom’s website, in the Wireless Telegraphy Register, which is available for download on this [page of the Ofcom website](#) (note column ‘AJ’ shows the licensee name).

We can confirm that MBNL have a fixed link site at that exact location.

We can confirm that EE have a shared site (shared with another mobile operator) approximately 30 metres from the grid reference coordinates you have provided.

Request an internal review
