## Freedom of Information request: Right to know request

Thank you for your request for information about the dates when companies became operators.

We received this request on 8 July 2025. We sought clarification of your request on 22 July 2025 and you responded with clarification on 18 August 2025. We have considered your request under the Freedom of Information Act 2000 and the Environmental Information Regulations 2004.

### Your request & our response

---

*We were in fact looking for when the companies listed below became operators whether by licence pursuant to the Telecommunications Act 1984 or subsequently by direction pursuant to the Communications Act 2003?:*

Clarified as:

*It would therefore be useful to have copies of the licences which would have been granted by the Secretary of State where the party became an operator prior to the Communications Act 2003. Where the party became an operator after the coming into force of the Communications Act 2003 we would like to have copies of the directions that may have been made for the benefit of that party. In some cases there may be more than one licence or direction and we would be grateful for copies of all licences and directions.*

In your clarification email, dated 18 August 2025, you added two companies to the request, namely Ioniqa Limited and Arqiva Limited.

We have interpreted your request to refer to the following documents in relation to the specified companies:

- a) directions relating to the [Electronic Communication Code](#) (ECC); and
- b) licences and licence amendments issued by Oftel.

### Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
