### Freedom of Information request: Right to know request

Thank you for your request for information concerning Openreach Infrastructure Data — Newport vicinity.

We received this request on 19 June 2025 and we have considered your request under the Freedom of Information Act 2000 (“the FOI Act”).

#### Your request

---

*Area: Newport : 100 Cae Perllan Road, Newport NP20 3FT. Request Scope;*

- 1. Locations of Openreach cabinets, fibre cabinets, exchange points serving the area.*
- 2. Any known underground or overhead telecoms infrastructure (ducts, poles) within 250 metres.*
- 3. Records of any Openreach-related public utility works or outages near this vicinity.*

#### Our response

---

We do not hold the requested information.

To be helpful, we would like to note, that Ofcom does collect some information from telecoms providers to understand take up of Openreach's regulated products and services as well as fibre build plans relevant to our telecoms market reviews. Relevant information, however, is not in a format that addresses the questions raised.

Any relevant information described above would be exempt from disclosure under Section 44 of the FOI Act. Section 44(1) of the FOI Act provides that information is exempt from disclosure if its disclosure is prohibited by or under any enactment. The enactment that prohibits the disclosure of this information is section 393(1) of the Communications Act 2003 (“the Communications Act”). Under this section, we are prohibited from disclosing information with respect to a particular business (such as individual telecoms companies) that has been obtained in the exercise of our regulatory functions, unless that business consents or one of the statutory gateways under section 393(2) of the Communications Act is met, neither of which apply here. Section 44 of the FOI Act is an absolute exemption and therefore is not subject to the public interest test.

### **Request an internal review**

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
