## **Our response**

---

We are unable to provide the information under your requests as we consider that section 12 of the FOI Act applies. Section 12 of the FOI Act provides that we are not obliged to comply with a request (or requests) for information if we estimate that the cost of complying with the request(s) would exceed the "appropriate limit". The appropriate limit is set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 (the "Regulations"), and is, for Ofcom, £450. That sum is intended to cover the estimated costs involved in determining whether Ofcom holds the information requested, locating, retrieving and extracting the information from any document containing it. The Regulations provide that costs are to be estimated at a rate of £25 per person per hour, which equates to 18 hours of time.

When calculating the cost estimate, under [ICO guidelines](#), we are permitted to aggregate requests from the same person which we receive within a 60 working day period, when the requests ask for the same, or similar, information. We note that your requests are mostly costs related. We estimate that it would take over 18 hours to search for, locate and extract the information you have requested.

We may be able to provide some information if fewer requests are submitted and if the requests are narrowed to include a more limited date range, for example one year. In any event some exemptions may apply.

## Information Requests

### Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

If you would like to ask us to carry out an internal review, you should get in touch within two months of the date of this letter. There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
