## Freedom of Information request: Right to know request

Thank you for your request for information about pirate radio seizures since 2015.

We received this request on 6 May 2025 and we have considered your request under the Freedom of Information Act 2000.

### Your request

*Details on the number of pirate radio stations that have been seized, shut down, or otherwise subject to enforcement actions by Ofcom (or in collaboration with other agencies) from 2015 to the present.*

*If available, I would also appreciate a breakdown by year and region.*

### Our response

---

Please note that we only hold the information requested for 7 years, in line with GDPR and data retention policies.

Tables A and B below show the breakdown of illegal broadcaster equipment seizures and other enforcement operations undertaken by Ofcom to disrupt illegal broadcasters. Please note that from 2022/23 we changed how this information was recorded to improve the quality of data captured; therefore, the numbers for the two periods of 2018/19 to 2021/2022 and 2022/23 to 2025/26 YTD are not directly comparable.

### Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

If you would like to ask us to carry out an internal review, you should get in touch within two months of the date of this letter. There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
