## Freedom of Information request: Right to know request

Thank you for your request for information about a number of licensed radio stations.

We received this request on 17 April 2025 and we have considered your request under the Freedom of Information Act 2000 ("the FOI Act").

### Your request

Could you please provide a description of each service, a detailed description of the content which comprises the services listed below and which multiplexes they broadcasts on. I would also like a copy of the licences and licence application forms. If possible could Ofcom also share a detailed financial breakdown of each service.

Could you also provide a detailed annual financial report for the years 2022, 2023 and 2024 for the services Raaj FM (CR000177BA/3), Gulshan Radio (CR100527BA/2), Club Asia (DP103264BA/1), Desi Radio (CR000061BA/3) and Ambur Radio (CR000175BA/4).

## Our response

## Licences and licence application forms

In the interests of clarity, we will address this part of your request first.

You have requested "a copy of the licences and licence application forms" for each of the services listed.

All the licence types you have asked about use the same licence template. The only variables are the licensee name, dates (e.g. grant date) and the annex (which details the service description, if DSP, or Key Commitments, if CDSP). Please use the following links to view the templates. Our table in Annex A provides the variable information:

- <u>Digital Sound Programme Service (DSP)</u> a licensee requires two licences if they are
  providing a service(s) on a local/regional/trial DAB/SSDAB multiplex as well as a service(s) on
  one of the two national DAB multiplexes. Licence numbers for the former are prefixed DP
  and DN for the latter.
- Community Digital Sound Programme Service (CDSP) licence numbers are prefixed CDP.

Regarding your request for copies of licence application forms for the services in your bulleted list above, we are unable to provide copies of the application forms for DSPs as we consider them exempt under the FOI Act. In particular, section 44(1)(a) of the FOI Act exempts disclosure of information if its disclosure is prohibited by or under any enactment. Section 393 of the Communications Act 2003 ("the Act") prohibits the disclosure of information about a particular business which has been obtained in exercise of a power conferred by, among other legislation, the Act, so long as that business continues to be carried on, unless we have the consent of that business or one of the statutory gateways under section 393(2) of the Act is met, neither of which applies here. Section 44 of the FOI Act is an absolute exemption and therefore is not subject to a public interest test.

For Part B of these applications, we are exempted from providing these as per section 44(1) of the FOI Act, as described above.

## Service descriptions and multiplex carriage information

You asked us to provide "a description of each service, a detailed description of the content which comprises the services [...] and which multiplexes they broadcasts on".

The annex to DSP licences contains a description of the licensed service. Please see the enclosed table at Annex A for the service description recorded in the DSP licences you have enquired about.

The annex to CDSP licences contains a set of Key Commitments. This information is published on the Ofcom website and so we have provided direct links to the Key Commitments for the named CDSP licences in the table at Annex A.

We keep records of which services are being provided on each licensed multiplex, based on regular updates from the multiplex licensees. The information documented in the Annex at the end of this

response letter is a snapshot using data held on 1 May 2025. Should you wish to clarify information, you may consider contacting the multiplex operator directly. The contact details are published on our website.

## Financial information and annual financial reports

For the services detailed underneath your bulleted list - Raaj FM (CR000177BA), Gulshan Radio (CR100527BA), Club Asia (DP103264BA), Desi Radio (CR000061BA) and Ambur Radio (CR000175BA) – you have asked for "a detailed annual financial report for the years 2022, 2023 and 2024."

Community Radio (CR) licences contain a condition which requires licensees to submit a finance report to Ofcom each year. The information is used to check whether the licensee has stayed within the financial limits set out in its licence in relation to on-air spot advertising and sponsorship income, and to inform Ofcom's community radio policy. It is also published in aggregated form in Ofcom's Communications Market Reports, which summarise the broadcasting sector over the past year. We are unable to disclose these finance reports or more specific information beyond that reported in our Communications Market Reports, as we consider that this information is exempt under section 44(1)(a) of the FOI Act, for the reasons referred to above.

**For the licensed services in your bulleted list**, you have requested "[i]f possible could Ofcom also share a detailed financial breakdown of each service." We interpret this part of your request as referring to information relating to financial records of the radio licensees listed in your request. We are unable to provide this information as we consider this is exempt under section 44(1)(a) of the FOI Act, as detailed above. If this is not the information you meant to refer to here, you are welcome to submit another request clarifying the information you would like us to provide.

#### Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

If you would like to ask us to carry out an internal review, you should get in touch within two months of the date of this letter. There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
