

Proposal to revoke Code Powers from certain companies

Statutory notification under section 107(6) of the Communications Act 2003

About this document

This document sets out Ofcom's proposal to revoke certain directions granting 'Code powers' to a number of companies.

The grant of Code powers is intended to assist persons that provide an electronic communications network and/or system of conduits. In particular, persons with Code powers may:

- construct and maintain infrastructure on public land (streets) without needing to obtain a specific street works licence to do so;
- benefit from certain immunities from the Town and Country Planning legislation; and
- apply to the Court in order to obtain rights to execute works on private land in the event that agreement cannot be reached with the owner of that land.

The specified companies have informed Ofcom that they are no longer making use of those powers and have requested Ofcom to revoke the directions.

Section 1

Summary

Purpose of consultation

- 1.1 Of com has granted powers pursuant to the electronic communications code (the "**Code**") to each of the following companies:

 - 1.1.5 Redcentric Communications Limited (formerly known as Redstone Communications Limited, with company registration number 03021292);
 - 1.1.6 Veolia Water East Limited (with company registration number 02663338);
 - 1.1.7 KDDI Europe Limited (with company registration number 02407242);
 - 1.1.8 Reliance FLAG Telecom Ireland Limited (a company registered in Ireland with company registration number 300330);
 - 1.1.9 Easynet Enterprise Services Limited (formerly known as VTL (UK) Limited, with company registration number 04287100);
 - 1.1.10 Thales Transport and Security Limited (with company registration number 3132438)
 - 1.1.11 Farice hf (registered in Iceland)
 - 1.1.12 Southern Water Ltd (with company registration number 2366620)

(together, the "Relevant Companies").

1.2 The directions granting Code powers to the Relevant Companies were made under section 106(3) of the Communications Act 2003 (the "**Act**")¹ and were granted in

order to assist those companies in providing an electronic communications network and/or system of conduits which they were making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks.

- 1.3 Of com has since received applications from each of the Relevant Companies requesting that Of com make a further direction under section 106 of the Act to revoke those Code powers.
- 1.4 Ofcom has reviewed each application for the revocation of Code powers and this document sets out Ofcom's proposal to revoke the directions applying the Code to each of the Relevant Companies, in accordance with sections 107(6), 115(2) and 115(4) of the Act.
- 1.5 Our reasons for that proposal are set out in Section 3 of this document and our draft direction revoking the directions applying the Code to each of the Relevant Companies is set out in Annex 4 to this document.
- 1.6 The closing date for responses to this consultation is 03 August 2015 and stakeholders wishing to respond are directed to Annex 1 for information on how to do so.
- 1.7 We will consider any responses received by the closing date before making our decision as to whether we should give a direction revoking the directions applying the Code to each of the Relevant Companies.

that those companies shall be treated as a person in whose case the Code applies by virtue of a direction given by Ofcom.

Section 2

Background

The Code

- 2.1 The Code is designed to facilitate the installation and maintenance of electronic communications networks². It confers rights on providers of such networks and on providers of systems of conduits which are made available for use by providers of electronic communications networks for the purposes of the provision of those networks, to install and maintain apparatus in, over and under land and results in considerably simplified planning procedures.
- 2.2 The Code only has effect in the case of a person to whom it is applied by a direction given by Ofcom (or, in the case of the Secretary of State or any Northern Ireland department, where the Secretary of State or that department is providing or proposing to provide an electronic communications network)³.
- 2.3 The only purposes for which the Code may be applied in a person's case by a direction are the purposes of the provision of:
 - 2.3.1 an electronic communications network; or
 - 2.3.2 a system of conduits which he is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks.

Revocation of the Code

- 2.4 Section 115(2) of the Act sets out that Ofcom may revoke a direction applying the Code in a person's case if an application for the revocation has been made by that person.
- 2.5 Section 115(4) requires that a revocation under section 115(2) shall be made by a further direction under section 106 of the Act to the person in whose case the Code has been applied by the direction being revoked.

Statutory consultation process on proposal

- 2.6 Before giving a further direction under section 106 of the Act revoking the Code from the companies in question, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification⁴.
- 2.7 Such a notification must contain the following⁵:
 - 2.7.1 a statement of Ofcom's proposal to revoke the direction applying the $Code^{6}$;

- 2.7.2 a statement of Ofcom's reasons for that proposal; and
- 2.7.3 a statement of the period within which representations may be made to Ofcom about the proposal (which period must end no less than one month after the day of the publication of the notification⁷).
- 2.8 The publication by Ofcom of a notification must be a publication in such manner as Ofcom considers appropriate for bringing the notification to the attention of the persons who, in Ofcom's opinion, are likely to be affected by it⁸.
- 2.9 The notification published at Annex 1 to this document is a notification for such purposes, which notification should be read in conjunction with the entirety of this document, including the reasons set out in Section 3.

Statutory duties

2.10 When carrying out its functions, Ofcom is required to act in accordance with its relevant duties set out in sections 3 and 4 of the Act; including its duties to further the interests of citizens in relation to communications matters and to promote the interests of all persons who are citizens of the European Union.

Impact assessment and equality impact assessment

- 2.11 An impact assessment, as defined in section 7 of the Communications Act 2003, must set out how, in our opinion, the performance of our general duties (within the meaning of section 3 of the Act) is secured or furthered by or in relation to what we propose.
- 2.12 There are two main options for this consultation:
 - 2.12.1 give a further direction revoking the direction applying the Code to each of the Relevant Companies; or
 - 2.12.2 not to give such a direction.
- 2.13 The analysis presented in the entirety of this consultation represents an impact assessment.
- 2.14 In carrying out our functions (again, something which includes giving a further direction to revoke the application of the Code), we are also under a general duty under the Equality Act 2010 to have due regard to the need to:
 - 2.14.1 eliminate unlawful discrimination, harassment and victimisation;
 - 2.14.2 advance equality of opportunity between different groups; and
 - 2.14.3 foster good relations between different groups,

in relation to the following protected characteristics: age; disability; gender reassignment; pregnancy and maternity; race; religion or belief; sex and sexual orientation.

- 2.15 Such equality impact assessments ("EIAs") also assist us in making sure that we are meeting our principal duty under section 3 of the Communications Act 2003.
- 2.16 We have therefore considered what (if any) impact the proposal in this consultation may have on equality. We do not, however, consider the impact of the proposal in this consultation to be to the detriment of any group within society. We have therefore not carried out separate EIAs in relation to race or gender equality, or equality schemes under the Northern Ireland and Disability Equality Schemes.

Section 3

Reasons for revocation

Introduction

3.1 This Section contains our reasons for our proposal to revoke each of the directions applying the Code to each of the Relevant Companies.

Explanatory Statement

Receipt of application for revocation

- 3.2 Each of the Relevant Companies have applied to Ofcom for the revocation of the direction applying the Code in their case, under section 115(2) of the Act.
- 3.3 Each of the Relevant Companies have explained that they are not exercising their Code powers and do not intend to do so in the future.

Ofcom's duties

- 3.4 In considering each of the applications made by each of the Relevant Companies, Ofcom considers that it has acted in accordance with its relevant duties set out in sections 3 and 4 of the Act; in particular, its duty to further the interests of citizens in relation to communications matters and to promote the interests of all persons who are citizens of the European Union.
- 3.5 Of com does not consider that the revocation of Code powers in these cases is contrary to its duties set out in the Act and will not prove to be detrimental to the interests of citizens in relation to communications matters. Each of the Relevant Companies have explained that they are not exercising their Code powers and do not intend to do so in the future. As a result, the revocation of Code powers from each of the Relevant Companies is unlikely to have little, if any, effect.

Proposal

3.6 For these reasons, Ofcom believes that it is appropriate to issue a further direction revoking the directions applying the Code to each of the Relevant Companies, as requested by each of the Relevant Companies. Thereafter, amongst other things, these companies would not be permitted to benefit from certain exemptions under Town and Country Planning legislation and nor would they be able to carry out works in connection with the installation of apparatus in the streets without the need to obtain a street works licence under the New Roads and Street Works Act 1991.

Annex 2

Ofcom's consultation principles

A2.1 Of com has published the following seven principles that it will follow for each public written consultation:

Before the consultation

A2.2 Where possible, we will hold informal talks with people and organisations before announcing a big consultation to find out whether we are thinking in the right direction. If we do not have enough time to do this, we will hold an open meeting to explain our proposals shortly after announcing the consultation.

During the consultation

- A2.3 We will be clear about who we are consulting, why, on what questions and for how long.
- A2.4 We will make the consultation document as short and simple as possible with a summary of no more than two pages. We will try to make it as easy as possible to give us a written response. If the consultation is complicated, we may provide a shortened Plain English Guide for smaller organisations or individuals who would otherwise not be able to spare the time to share their views.
- A2.5 We will consult for up to 10 weeks depending on the potential impact of our proposals.
- A2.6 A person within Ofcom will be in charge of making sure we follow our own guidelines and reach out to the largest number of people and organisations interested in the outcome of our decisions. Ofcom's 'Consultation Champion' will also be the main person to contact with views on the way we run our consultations.
- A2.7 If we are not able to follow one of these principles, we will explain why.

After the consultation

A2.8 We think it is important for everyone interested in an issue to see the views of others during a consultation. We would usually publish all the responses we have received on our website. In our statement, we will give reasons for our decisions and will give an account of how the views of those concerned helped shape those decisions.

Background

1. Of com has issued directions, pursuant to section 106(3) of the Act or paragraph 17(2) of Schedule 18 of the Act, applying the Code in the case of each of the Relevant Companies.

2. Each of the Relevant Companies have since applied to Ofcom for a further direction revoking the directions referred to in paragraph 1 above, in accordance with section 115(2) of the Act.

3. Prior to making a direction under section 106(3) of the Act to revoke the directions referred to in paragraph 1 above, Ofcom must publish a notification of its proposal to give that direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.

4. On 03 July 2015, Ofcom published, in accordance with sections 115(4) and 107(6) of the Act, a notification of its proposal to give a further direction revoking the directions referred to in paragraph 1 above for the reasons set out in the consultation document accompanying that notification. That notification invited representations to Ofcom by no later than 5pm on **03 August 2015.**

5. Ofcom has considered every representation about the proposal received and duly made to it. For the reasons set out in the explanatory statement accompanying this proposed Direction, Ofcom has considered and acted in accordance with its general duties in section 3 of the Act and the six Community requirements in section 4 of the Act.

Decision

6. Ofcom hereby directs, in accordance with section 106 of the Act, that each direction applying the Code in the case of each Relevant Company under section 106(3) of the Act shall be revoked.

7. In this proposed Direction, unless the context otherwise requires and subject to paragraph 8 below, words and expressions used in this proposed Direction shall have the same meaning as they have been ascribed in the Act.

8. In this Notification—

- (a) "Act" means the Communications Act 2003;

- (d) **"Relevant Companies**" means each of the companies listed in the Appendix to this Direction.
