We feel that any future imposition of a charge, for example an annual fee, may have a detrimental effect on recruiting young members to amateur radio

We feel that the present procedure should be made more strict. We feel that station ID is mandatory at shorter intervals than at present, say every 10 minutes, would be beneficial. In addition, the different requirements for the 5MHz band is confusing. We feel that a consistent requirement across all bands is best.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

No

We feel that the use of Regional Secondary Locators and suffixes should be clarified but not dispensed with. We feel that the use of RSLs should be mandatory to indicate the current location of the station, i.e. where the station is transmitting from, and that a suffix should be used to indicate when the station is operating away from the registered home location or QTH. RSLs are helpful to locate the station geographically and radio amateurs are accustomed to their use.

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:
