Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

Yes, I agree with the proposal to include th e470kHz and 5MHz bands in the licence conditions fro all Amateur Radio (Full) licensees. I have concerns about the conditions attached to the use of these bands however interference to "electronic equipmen"t has not previously been included in licence conditions. Cases of interference to electronic equipment are invariably due to insufficient immunity in such equipment - this should be omitted. Similarly, requirements that the licensee must take suitable precautions, particularly in

locations to which people have access, to minimise the risks associated with exposure to Radio Frequency ("RF") radiation. Have not been included previously - this should be omitted.
