Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

No - but the issue is with what is proposed. I do agree that the 470kHz and 5MHz bands

should be included in the Full Licence but on a non-interference Secondary basis.

I have real issue with the statement, "The station must not cause interference to, and may not claim protection from other wireless telegraphy or electronic equipment." I am particularly concerned with the inclusion of 'electronic equipment' in the wording.

I have worked as a professional EMC consultant for many years. There are far too many pieces of electronic equipment in circulation that have poor immunity to RF transmissions.

They do not meet the requirements of the European EMC Directive or FCC part 15. It should be the responsibility of a Radio Amateur to ensure his transmissions are within band but he or she cannot be held responsible for the poor RF immunity of electronic equipment.

Both Paragraph 2.26.6 and the wording 'electronic equipment' in 2.26.3 should be deleted.

Question 2:Do you agree that expressly linking a Full (Club) Licensee?s authorisation to use the spectrum to his or her representation of a named club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club?s call sign remains with the club?:
