Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

I accept that the 470khz and 5Mhz bands be included in ALL FULL (Advanced) Amateur Radio licensees in exactly the same way as other Secondary basis bands. The 470khz and 5Mhz bands should NOT be included for Intermediate and Foundation Licensees. Paragraph 2.26.3 phase 'Electronic Equipment' should be removed in its entirety along with paragraph 2.26.6.

Question 2:Do you agree that expressly linking a Full (Club) Licensee's authorisation to use the spectrum to his or her representation of a named club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club's call sign remains with the club?:

Yes agree with this.

Question 3:Do you agree that Ofcom should include a further ground of revocation in the Licence as proposed above in order better to align Clause 4 with the definition of 'Disqualified Person':

Question 6:Do you agree that Clause 13 of the Licence should be amended to allow for a simpler, more flexible approach for identifying Amateur Radio stations?:

No, not as proposed. Why change what is currently working ok. If you want to change anything lets do away with the /A, which is confusing.

Keep the rule that we must be clearly identifiable and call sign to be given at the beginning and end of each period of transmission and not exceeding 15mins.

Question 7:Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

No, there is no need to change current mandated and widely accepted practice. Any change would cause both confusion to both Nationally and Internationally. Why do away with 50years practice which is fully understood.

Question 8:Do you agree with Ofcom's proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

No, All licences should be treated in the same way by retaining the current clause in respect to the Callsign prefix.

Question 9:Do you agree that replacing Clauses 2(1) and 16(1) with a new Clause to simplify and bring together all of the licence conditions relating to the operation of radio equipment away from the Main Station address will make these provisions clearer?:
