Question 1:Do you agree with the proposal to include, as a matter of course, the 470 kHz and 5 MHz bands into the Licence for all Amateur Radio (Full) licensees?:

No, not as proposed. I agree that the the 470 kHz and 5 MHz bands should be made available to all holders of a full licence. The existing wording for other bands that are used on a secondary basis should also be used for these bands.

Paragraph 2.26.3 should be restricted to wireless telegraphy equipment. Please delete paragraph 2.26.6.

Question 2:Do you agree that expressly linking a Full (Club) Licensee?s authorisation to use the spectrum to his or her representation of a named club, and by adding a further ground for revoking the Licence to include circumstances where the licensee no longer represents the club, will help ensure that a club?s call sign remains with the club?:

I see no need to change this clause in respect of the need for the station to identify itself every 15 minutes. Identification should be compatible with the mode being used, but please do not be prescriptive about specific modes.

Question 7: Given the current uncertainty amongst Radio Amateur licensees in relation to Clause 2(2), do you believe that it would be a practical solution for Ofcom to remove this Clause and to insert additional wording into Clause 13, as proposed above?:

There is no uncertainty.. RSLs have been used for many years. The licence should mandate the use of RSLs to indicate the region in which the radio signal is emanating from.

Question 8:Do you agree with Ofcom?s proposal to amend Clause 2(3) of the Licence to require Intermediate licensees to transmit a call sign that reflects the location of their main station?:

I disagree. As for foundation and full licensees, the RSL for intermediate licensees should be used to indicate the region in which the radio signal is emanating from. The RSL should NOT indicate the region of the main station, unless that is where the radio signal is emanating from.
