The established UK system of RSL achieves that in a way that is widely known and understood. Any unilateral change by OFCOM would thus have a negative impact on stakeholders, not only in the UK but around the world. That impact would need to be formally assessed and could only be justified in terms of some overriding need. RSGB sees no such need or justification for changing the existing system."

So how OFCOM can say that there is "uncertainty amongst Radio Amateur licensees in relation to Clause 2(2)," is certainly not true!
