## **Additional comments:**

Ofcom should state clearly that the Amateur Licensing arrangements are intended to be progressive:-

1st & Samp; ndash; Foundation 2nd & Samp; ndash; Intermediate

3rd & amp; ndash; Full.

Progression should be encouraged by giving additional privileges. For example / suggested discussion -

1st foundation - 10 watts at transmitter, bands two, say 10m & amp; amp; 70cm.

2nd intermediate - 100 watts at transmitter, bands As foundation plus say 2m, 4m, 6m, 10m & 2m; 23cms.

3rd full - 400 watts at transmitter / maximum allowed on band, bands all.

My above suggestions should be applied to all current and future licences. Some would see

removing privileges as unfair. But please remember all amateur licences can gain or loose privileges and historically this has happened.

Regional identifiers. I can not understand people's confusion with adding / removing the regional identifier. Leave it alone it works.

Intermediate callsigns. If the 2?0ABC / 2?1ABC is a problem for Ofcom, consider changing all intermediate calls to one in line with the G or M format. For example selecting an old call eg the G2ABC series and reissuing that series to the intermediate licence.

In addition to the above, once a person has progressed to the next level of licence, their old callsign should be revoked / exchanged for their new callsign. This would release callsigns for future use and ensure the licence figures are accurate.

I make these points as an amateur of 29 years experience. I was first licenced aged 18 and I am an approved instructor for the current amateur examinations.

As an instructor I believe there needs to be an incentive to progress through the licence structure. In my opinion the foundation licence gives the successful candidate far too many privileges for such a low level of knowledge.
